Doc turns predator

Cuttack, August 13: A senior resident doctor at SCB Medical College and Hospital's Cardiology department was arrested Tuesday on charges of sexually assaulting two patients on the hospital premises Sunday.

Cuttack DCP Prakash R said Thakur Dilbag Singh, a native of MP Nagar in Bhopal, was arrested after his discharge from ICU, where he was admitted following a scuffle reportedly with the relatives of the victims soon after the crime Sunday.

Singh has been booked (Case no-201/24) by the Mangalabag police under Section 64(2)(e) of BNS, the DCP added.

According to a release by the Commissionerate Police, the complainant in the case consulted with the accused doctor for necessary echocardiogram test on his mother, 51, and aunt, 44, suffering from cardiac issues August 9. The doctor fixed the appointment for Sunday.

At around 10am Sunday, the complainant turned up with the patients at the Cardiology department.

Police said the accused doctor asked the complainant and female attendant/staff not to remain present during the tests.

"He conducted tests one by one taking 30 minutes for each patient. Taking advantage of the situation, the doctor carried out penetrative sexual assault on

both the victims," police said.
When the victims complained
of acute pain in their private
parts, the complainant took them



to the O&G department for treatment, they said.

Following the development, police recorded the victims' statements and their medico-legal examination was also conducted. Their statements were also recorded before a court here, they added.

Meanwhile, the Health and Family Welfare (H&FW) department has set up a threemember committee to probe into the allegations against the resident doctor.

The panel shall undertake a detailed inquiry and recommend appropriate action to the government, a notification issued by the H&FW department said.

SCB superintendent Sudhanshu Sekhar Mishra was unavailable for comments.

The incident came at a time when doctors across the country are bunking work, demanding protection and security at workplace following the horrific rape and murder of a doctor in a Kolkata hospital last week.

CBI takes over Kolkata doc rape-murder probe

New Delhi/Kolkata: Hours after the Kolkata High Court's direction, the CBI Tuesday took over the investigation in the alleged rape and murder of a woman doctor at a state-run medical college in the West Bengal capital. The agency swiftly completed all formalities following the High Court order asking the state police to hand over the case documents to the Central probe agency, officials said. A team of CBI officials from Delhi along with forensic scientists and medical experts will visit Kolkata Wednesday, they said.

Nod for 4 new NH projects

Bhubaneswar, August 13: The Centre has approved four new NH projects worth around ₹14,000 crore for Odisha, Chief Minister Mohan Charan Majhi said after a meeting with Union Road Transport and Highways Minister Nitin Gadkari in New Delhi, Tuesday.

These projects include 6-laning of the 60 km Bhubaneswar-Puri NH with two-lane service road worth ₹1,800 crore, 200km Chandikhole-Barbil 8-lane worth ₹10,000 crore, 54km Khurda-Nayagarh (NH-57) 4-lane worth ₹1,100 crore and 46km Kesinga-Junagarh (NH-26) 4-lane worth ₹1,000 crore, Majhi said.

Majhi told reporters that the state government is working in close coordination with the Centre for the development of national highways in Odisha.

"Detailed discussion was held for several important NH projects in the state and the Centre agreed to speed up steps for im-

plementation of four major projects," Majhi said.

Gadkari said that DPR for the four NH projects as proposed by the state government will be prepared soon, the CM said.

Law Minister Prithiviraj Harichandan, Chief Secretary Manoj Ahuja and senior officials were present during the CM's meeting with Gadkari.

Majhi said widening of the NH between Bhubaneswar and Puri along with service road will play a significant role in boosting tourism by attracting pilgrims and other visitors from different parts of the country.


Gadkari reviewed the progress of 51 ongoing NH projects in Odisha during the meeting.

Bhagat suspended, to miss Paralympics

New Delhi, August 13: Tokyo gold medallist para shuttler Pramod Bhagat will not be able to defend his title at the Paris Paralympics after he was handed a 18-month suspension for breaching Badminton World Federation's (BWF) anti-doping whereabout clause, leaving the Indian heartbroken.

"The BWF can confirm India's Tokyo 2020 Paralympic champion Pramod Bhagat has been suspended for a period of 18 months and will miss the Paris 2024 Paralympic Games," the governing body said in a statement Tuesday.



"In 1 March 2024, the Court of Arbitration of Sport (CAS) Anti-Doping Division found Bhagat in breach of the BWF anti-doping regulations for committing three whereabouts failures within 12 months." The 36-year-old, an SL3 athlete, said he is saddened by the decision and it was a result of a technical glitch.

"It is an extremely hard decision for me. I respect WADA, I understand they are drawing a line for all players, but to ban someone for technical reasons is not right," Bhagat told PTI.

SC relief for Ramdev, Patanjali

New Delhi, August 13: In a relief to yoga guru Ramdev, his aide Balkrishna and Patanjali Ayurved Limited, the Supreme Court Tuesday closed the contempt proceedings initiated against them for "violation" of the undertakings given before the court in the misleading advertisements case.

While the apex court accepted their apology and closed the matter, it cautioned them to strictly abide by the terms of their undertakings.

"Any future intransigence on their part, whether by act, deed or speech that could tantamount to violating the orders of the court or dishonouring the terms of the undertakings, shall be viewed strictly and the ensuing consequences could indeed be grave," a bench of Justices Hima Kohli and Ahsanuddin Amanullah said.

"In that eventuality, the sword of contempt that has now been returned to rest in its sheath, shall be flourished as swiftly as these proceedings were originally initiated," the bench said in its 41-page verdict.



Amend Odisha Universities Act, Pradhan tells CM



Bhubaneswar, August 13: Union Education Minister Dharmendra Pradhan has written a letter to Chief Minister Mohan Charan Majhi seeking rectification of the discrepancies in the Odisha Universities (Amendment) Act, 2020 brought by the previous BJD government.

The Naveen Patnaik government had earlier amended the original Act, which not only created conflict in the provisions of the UGC Act but also diluted the interest of educational institutions and their autonomy, Pradhan alleged.

The Union minister claimed that the previous government had taken steps to curtail the autonomy of state's educational

Pradhan urged the Chief Minister to amend the Act, as per the legal and regulatory frame-

This amendment is important to restore confidence among educationists, safeguard the autonomy of educational institutions and ensure that Odisha maintains the highest standards of education, he said.

The previous BJD government had enacted the Odisha University (Amendment) Act bringing many extensive amendments to the original Act of 1989.

The provisions contained in the prevailing Act regarding selection of chancellors, and recruitment of teaching staff in universities are not only inconsistent with these regulations of UGC but also ignore judicial directives laid down by the Supreme Court, he further stated.

Therefore, the efforts made by the previous government to undermine the credibility of the educationists and educational institutions of the state should be reconsidered immediately,

Stay on minor mineral mining

Bhubaneswar/Baripada, August 13: The National Green Tribunal (NGT) has ordered a stay on mining of minor minerals in Mayurbhanj district, official sources said, Tuesday.

The move by the Eastern Zone Bench of the NGT comprising judicial member B Amit Sthalekar and expert member Arun Kumar Verma came August 8 while hearing a plea filed by environmentalist Bibekananda Pattnaik.

The petitioner had informed the environment watchdog that the authorities have published a notification for auction of Belonapura, Madhunanda, Demphouda of Budhabalang Sandbed-I under Betanati tehsil in Mayurbhani district June 20 this year for a period of five year.

"Though the notification claimed that the mining quarry is below 5 hectare, the interim



District Survey Report mentions it as 5.01 hectare," the petitioner said in his complaint.

Taking cognisance, the environment watchdog asked the Mayurbhanj Collector to submit a report in this regard within

The district Collector later submitted a revised District State Level Environmental Impact Assessment Authority

(SEIAA) did not approve it. Highlighting that a proper District Survey Report is a prerequisite for auction of minor mineral quarries, the petitioner claimed that the June 20, 2024 auction notification is in violation

Taking note, the NGT ordered a stay on mining of minor minerals in the district till further of the petitioner.

"...we direct that no mining activity shall be carried out in the district (Mayurbhanj) under the interim District Survey Report until further orders of the court," the Eastern Zone

The environment watchdog will hear the issue October 3, 2024. it said.

According to sources, there are 203 minor mineral quarries under 26 tehsils of the district. While 161 quarries—77 sand, 83 stone and one morrum—are under the Mines department, remaining 42 quarries are entangled in many NGT cases,' they said.

According to state government statistics, 70 quarries-40 sand. 29 stone and one morrum have been leased out.

Senior lawyer Sankar Prasad Pani presented the case on behalf

ECoR adopts ballastless track technology in new projects

Bhubaneswar, August 13: In what would revolutionise the safety, efficiency and sustainability of rail transport, the East Coast Railway (ECoR) has been adopting advanced ballastless track technology in railway tunnels while constructing new projects in its jurisdiction, official sources said Tuesday.

ECoR initially started ballastless track in tunnel with Rheda 2000 Block System for Tunnel No.1 (600 metre) between Baliguda and Kakiriguma stations in connection with Koraput-Singapur Road doubling project.

This ballastless track system will also be implemented at all the under-construction tunnels of various ongoing projects

under ECoR, they said Plans are on to replace exist-

ing tracks in tunnels with ballastless tracks. "Tunnel works are on in Kothavalasa-Kirandul and Koraput-Rayagada doubling projects, and Khurda Road-Bolangir and Talcher-Bimlagarh new line projects," they said.

Ballastless train tracks, particularly in tunnels, offer several significant advantages that are ideal for various key merits.

"Ballastless tracks are more robust and require less maintenance compared to traditional tracks. The absence of ballast eliminates issues like ballast degradation and shifting, which can cause track misalignment," The materials used in bal-

lastless tracks, such as concrete and steel, provide a longer service life, making them a more sustainable option for tunnels. Without ballast, the track

structure is more rigid, ensuring consistent alignment and reducing the risk of derailment. This stability is especially crucial in tunnel environments where space is confined.

Ballastless tracks can handle higher loads, making them suitable for high-speed rail or heavy freight traffic that may pass through tunnels. The robust design and construction of ballastless tracks mean that they require less frequent maintenance. This is particularly beneficial in tunnels, where access for maintenance work is often more challenging and costly

India successfully flight tests GAURAV

Balasore, August 13: India Tuesday successfully test-fired a Long Range Glide Bomb (LRGB), GAURAV, from the Su-30 MK-I platform of the Indian Air Force off the Odisha coast.

The test was organised by the Defence Research and **Development Organisation**

GAURAV is an air-launched 1,000 kg class glide bomb capable of hitting targets at long distances. After being launched, the glide bomb steers towards the target using a highly accurate hybrid navigation scheme with a combination of INS and GPS data. GAURAV has been designed and developed indigenously by the Research Centre Imarat (RCI), Hyderabad, defence sources said.

During the flight test, the glide bomb hit the target erected at Long Wheeler's island with pinpoint accuracy, they said adding that complete flight data during the test launch was captured by Telemetry and Electro optical tracking systems deployed by Integrated Test Range along the coastline.

The flight was monitored by senior DRDO scientists. Adani Defence and Bharat Forge, the Development cum Production Partners also participated during the flight trial, they said.

Defence Minister Rajnath Singh complimented DRDO, IAF and industry for the successful flight test.

He termed it as a major milestone in the country's effort in developing indigenous defence technologies for further strengthening the capability of the Armed Forces.

Parliamentary Affairs Minister Mukesh Mahaling told reporters that Union Health Minister JP Nadda, Education Minister Dharmendra Pradhan and Tribal Affairs Minister Jual Oram are scheduled to address the MLAs during the event. In the 147-member House, 82 are first-time legislators, the official said.



Bhubaneswar, August 13: Vigilance sleuths Tuesday arrested Tara Prasad Mishra, a retired engineer of Works department, a day after unearthing disproportionate assets (DA) worth crores of rupees from his possession.

Mishra was found in possession of DA, including 10 highvalue flats in Bhubaneswar and Jharsuguda, seven costly plots, $2.55~\mathrm{kg}$ of gold, and $370~\mathrm{gram}$ of diamond.

During simultaneous raids conducted at nine locations in Bhubaneswar, Cuttack, and Jharsuguda Monday, Vigilance sleuths also detected deposits over ₹2.70 crore, ₹6 lakh in cash, two luxurious cars, from his pos-

The investigation also uncovered Mishra's visits to for-



eign countries like the USA Thailand, Vietnam, UAE, Canada, Malaysia, and Singapore.

When asked about the source of income, Mishra could not explain satisfactorily, they said.

A corruption case was registered against the retired engineer in the Bhubaneswar Vigilance police station following which he was arrested, the officials said.

All Indian salt, sugar brands have microplastics: Study

ll Indian salt and sugar brands, whether big or small, packaged or unpackaged, contain microplastics, according to a study published Tuesday.

The study 'Microplastics in Salt and Sugar', conducted by the environmental research organisation Toxics Link, tested 10 types of salt - including table salt, rock salt, sea salt and local raw salt - and five types of sugar purchased from both online and

local markets. The study revealed the presence of microplastics in all salt and sugar samples, in various forms, including fibre, pellets, films and fragments. The size of these microplastics ranged from 0.1mm to 5mm.

The highest levels of microplastics were found in iodised salt in the form of multi-coloured thin fibre and films.

Toxics Link founder-director Ravi Agarwal said, "The objective of our study was to contribute to the existing scientific database on microplastics so that the global plastic treaty can address this issue in a concrete and focused manner.'

"We also aim to trigger policy action and attract researchers' attention to potential technological interventions that could reduce exposure risks to microplastics.'

Iodised salt had the highest concentration of microplastics (89.15 pieces per kilogramme) while organic rock salt had the lowest (6.70 pieces per kilogramme), according to the study.

In sugar samples, the concentration of microplastics ranged from 11.85 to 68.25 pieces per kilogramme, with the highest concentration found in nonorganic sugar.

Microplastics are a growing global concern because they can harm both health and the environment. These tiny plastic particles can enter the human body

through food, water and air. Recent research has found microplastics in human organs such as the lungs, heart, and even in breast milk and unborn ঽ babies.

Previous studies found that the average Indian consumes 10.98 gram of salt and around 10 spoons of sugar every day much higher than the World-Health Organisation's recom-

mended limits.

Singh Deo expressed his gratitude to the Panchayati Raj and

Drinking Water department, National Informatics Centre (NIC), and Tata Power Limited for their collective efforts.

On the occasion, Naik directed the officials to implement the system properly in the concerned areas.

The portal was jointly developed by the Energy Department, Panchayati Raj and Drinking Water department, NIC and Tata Power Limited, the officials said.

According to them, the initiative aims to provide uninterrupted road lighting and drinking water supply facilities to rural areas, with a focus on transparency and accountability.

Swaraj online platform, the portal enables Panchayats to easily access, approve, and pay electricity bills within a day, using a secure OTP system," they said.

"The system will be used for the management of grants provided by the Central and State Finance Commissions," they added.

OMBADC's initiative for better crop cultivation Patnaik urges all

Sundargarh/Bhubaneswar, August 13: In order to ensure good crop yields throughout the year, Odisha Mineral Bearing Areas Development Corporation (OMBADC) is financially supporting Sundargarh district to construct farm ponds to provide irrigation facility to farmlands. According to OMBADC, a total

India faces a severe organ wastage crisis, say experts behind India's severe organ wastage crisis that leads to the

superstitions, and myths are loss of vital organs annually, said experts Tuesday on World Organ Donation Day. World Organ Donation Day is

observed every year August 13 to raise awareness about the importance of organ donation and to dispel myths surrounding it. India's cadaver organ donation rate has been abysmally

low and stands at less than one per million people in the country. In stark contrast, Western countries have 70-80 per cent deceased organ donation. "India faces a severe organ wastage crisis, losing approximately 2 lakh kidneys and other

vital organs annually due to a lack of awareness, deep-rooted superstitions, and myths surrounding brain death," Tanima Das Bhattacharya, Consultant - Nephrologist and Kidney Transplant, Narayana Health, Kolkata, told IANS Bhattacharya added that the

"loss is compounded by the failure to properly identify and certify brain deaths in hospitals, significantly reducing the country's organ donation rates despite the availability of potential donors."

The experts noted that even with recent directives from the Union Health Ministry to improve documentation of brain stem deaths, the cadaver organ





donation rate remains alarmingly low -- less than one donor per million population per year.

"In a country as populous as India, it is a tragic irony that thousands of life-saving organs go to waste each year. The gap between the number of available organs and the patients in need is vast, and the wastage of viable organs due to logistical and systemic challenges is a critical issue that demands immediate attention," Rajesh Aggarwal, Director, Nephrology and Kidney Transplant, Sri Balaji Action Medical Institute, Delhi,

told IANS. Suganthi Iyer, Director-Legal and Medical, PD Hinduja Hospital and Medical Research Centre added that organ wastage

in India can be significantly reduced by addressing the lack of awareness among healthcare professionals and the public, particularly in rural areas, about organ donation post-brain stem death.

"Additionally, increasing the number of hospitals registered as Non-Transplant Organ Retrieval Centers (NTORC) is crucial. Focused training for healthcare workers and community outreach can further help

curb wastage," she told IANS. Citing the example of Spain, Bhattacharya suggested shifting India's focus from Donors after Brain Death (DBD) to Donors after Circulatory Death (DCD). This has huge potential to curb organ wastage, he noted.

Bhubaneswar: Regional Science Centre (RSC), in association with Dr Agarwal's Eye Hospital and SUM Ultimate Medicare (SUMUM) observed the World Organ Donation Day (WODD) at RSC campus here, Tuesday. On the occasion, a free eye checkup camp for the general public



and interactive sessions spreading awareness about organ donation was organised. SUMUM organ transplant coordinator Anindita Sabath hosted an interactive session and highlighted the importance of organ donation in saving and transforming the life of the recipient. In another session, squint and cataract surgeon Chandra Shekhar Sahoo interacted with the participating students to make them aware about how the donated eyes can be used to restore vision in people suffering from corneal blindness. RSC project coordinator Kapil Jain stressed on the significance of the day, themed 'Be the Reason for Someone's Smile Today'. Around 200 students from different institutes participated in the programme.

Keonjhar, August 13: Funds of over ₹700 crore belonging to the District Mineral Foundation (DMF) in this district have been misappropriated or spent by various departments without the approval of the trust board, sources alleged Tuesday. The matter became public after activist Subhakanta Nayak filed an application to get information about how the money has been spent under the Right to Information Act (RTI).

After he received the information, Nayak subsequently lodged a complaint with Chief Minister Mohan Charan Majhi, Chief Secretary Manoj Ahuja and various other departments. In the copies he pointed out that in many cases funds have been spent without inviting tenders and observing DMF guidelines. He stated that large amounts have been sanctioned for departments that do not have the right to use DMF funds. Sources said that if a proper investigation is carried out, the misappropriation amount could well be over ₹2,000 crore. On



receipt of the complaint, Ahuja has asked the collector of this district to conduct a probe and submit a report.

Sources said funds worth ₹250.41 crore has been sanctioned from DMF, Keonjhar to the district education officer, ₹18.61 crore to OREDA, Bhubaneswar, ₹48.20 crore to chief development officer, Zilla Parishad, Keonjhar, ₹5 crore to district welfare office, ₹14.55 crore to the district employment exchange, ₹31.10 crore to the district fishery office, ₹31.79 crore to the chief district veterinary officer

(CDVO), ₹28.68 crore to the crore to the office of the district Horticulture department, ₹8.38 crore to the executive engineer of Odisha Lift Irrigation Corporation, ₹3.5 crore to the office of the chief agriculture officer and ₹59.81 crore to the district Social Welfare department. However, the highest amount of ₹102.89 crore has been sanctioned to the office of the district project coordinator. Similarly ₹42.50 lakh have been sanctioned to district manager, OFDC.

Mobile game addiction leads to youth's suicide

Jajpur, August 13: A 22-year-old man allegedly died by suicide after failing to repay loans he had taken from people after suffering losses to the tune of lakhs of rupees in mobile games, police stated here Monday. The deceased, identified as Srinivasa Nayak alias Lincoln, was the only son of Brajabandhu Nayak. He used to work for a private mining company.

The incident happened Sunday night in Kadubani village under the jurisdiction of Kaliapani police station, a police officer said. He added that the deceased used to play online games on his mobile phone and in the process suffered huge financial losses.

Lincoln had dinner with his family before going to his bedroom Sunday night. When he did not wake up next morning, the concerned family members knocked on his door. After not get-

ting any response they broke open the door hanging from the ceiling.

To mitigate the losses he incurred due to online gaming, Lincoln had taken loans from various self-help groups in his village through his mother. Facing relentless pressure from moneylenders to repay the debts, Lincoln took the drastic step to end his life, police said.

The police later recovered the body and sent it for post-mortem. After registering a case of unnatural death, police have initiated an investigation to ascertain the circumstances leading to Lincoln's suicide.

"We are investigating the case to ascertain the circumstances leading to the suicide of the youth. We are also examining his bank records, which may shed further light on the reasons behind his tragic decision," said a senior police officer.

Musk's Trump Card

The world's richest and possibly, in near future, it's most powerful man featured in a rare interview that had not only a pan-American, but also global audience recently. Tech titan Elon Musk let the US presidential candidate Donald Trump use his X platform and add a new dimension to his electoral campaign, spinning conspiracy theories and launching anti-immigration campaign. It was an attempt to win sympathy from American voters and at the same time project himself as a rough and tough person fit to lead the country. Musk helped Trump's image-building task by lauding him for his "courage" in the face of the recent attempt on his life. This was the much needed shot in the arm for Trump who was taken off guard by President Joe Biden's late decision to withdraw from the contest and let his deputy, Kamala Harris, take his place. This robbed Trump's campaign team much of the fire power reserved for Biden. The interview by Musk is thus being seen as an attempt to slow the rise of Democratic nominee Harris.

In fact, the mega show marked an extraordinary chapter in a presidential campaign which is likely to turn the contest into a bitterly fought one with the promise of a nail-biting finish. The former president has been struggling to take on Harris who has been getting record donations. At one stage Trump repeated his charge against Harris that "she is a believer in being radical left." The interview revealed that Trump is jittery as he said without a shred of evidence that Biden had been illegally ousted to make way for Harris. He even went to the length of accusing Harris of engineering a "coup of the President of the United States."


Musk has been a critic of Trump, but of late he seems to have made up his differences with him. He at once agreed with Trump that Kamala Harris was a radical leftist and sought to massage his ego by implying that he was strong and the US needs such a leader as its President.

The high profile interview itself is a media coup of sorts in that no media campaign can match it. Musk turned into a Trump apologist and left no one in doubt that he wants to see him win a second term. "You are the path to prosperity. And I think Kamala is the opposite," he told Trump. It was a rank partisan interview that gives a broad hint that Musk's business interests merge with Trump's political interests.

In fact, Trump told Musk during the interview that once he wins the election he could use his service in the government. It appeared Musk is keen on securing favourable treatment from the next administration for advancing his huge business interests. For this he willingly provided the Republican nominee an audience of at least 1.3 million concurrent listeners at the worst moment of his campaign so far. And he predicted at least 100 million people would consume the content in the coming days. Musk's companies, including SpaceX, a key player in the US space programme, and Tesla, which makes electric vehicles, can be hit if a victorious Trump makes policies not favourable to Musk's interests. In fact, Trump had reservations about Musk's electric car productions, but he has softened his stand on it.

The entire conversation runs the risk of being a clash of potential conflicts of interest. It is to be seen how Team Harris offers a counter

Consider the chaos that engulfed Sri Lanka in 2022, when a severe economic crisis triggered mass protests against the Rajapaksa brothers' dynastic, un-democratic regime. Though President Gotabaya Rajapaksa, like Hasina, initially unleashed a violent crackdown. his opponents proved too powerful. Like Hasina, he gave up and fled the country, without even formally resigning. Sri Lankan protesters then occupied the presidential palace, much as Bangladeshi mobs have ransacked Hasina's sprawling official residence

But when an autocrat is toppled, it is often the military – not a democratic government – that takes over, even if behind a civilian facade. Bangladesh is no exception. The military has attempted at least two dozen coups since the country's violent birth

in 1971, and ruled for a number of extended periods since its 1975 assassination of Bangladesh's charismatic founding leader, Sheikh Mujibur Rahman.

Hasina, who is Rahman's daughter, stood out for her success at keeping the military (and Islamists) in check, at least until last week, when the army chief refused to continue supporting her crackdown on rampaging protesters. The military then facilitated her escape to India and established an interim government of civilian "advisers" who have little experience with national issues.

To be sure, some South Asian countries have made some progress toward democracy. In particular, Bhutan's democratic transition is proceeding apace, thanks to a benevolent king who has supported the transition from a traditional monarchy to a parliamentary system. Earlier this year, the country's fourth national election brought an opposition party to power.

But elections alone – even if competitive – do not guarantee popular empowerment or adherence to constitutional rules, especially when the military holds decisive power. Consider Pakistan, which held elections earlier this year. The military's preferred candidate, Shehbaz Sharif, returned as prime minister, but his government will survive only at the pleasure of the country's effective ruler, the army chief. Until the rule of law

is firmly entrenched and those wielding extra-constitutional power are unequivocally reined in, democratic progress will remain limited and reversible.

Myanmar learned this the hard way. Though the military had called the shots in the country since independence in 1948, it began ceding power to a nascent civilian government in 2015, filling the country with hope for a democratic future. But in February 2021 – barely six years later – it staged a coup. This time, however, resistance has proved intense, and heavily armed insurgent groups - some receiving "non-lethal aid" from the United States – are managing to expand their territorial control. In response, the military junta has stepped up punitive air strikes and artillery barrages.

The violence and deepening humanitarian crisis are fueling instability beyond Myanmar's borders. Already, more than 32,000 ethnic Chin have sought refuge in India's Mizoram state, and thousands more have fled to the state of Manipur, where their arrival has stoked violent ethnic conflict. And it is not just the Chin: India is also home to millions of illegal immigrants from Bangladesh whose ranks are set to grow as desperate Hindus flee Islamist attacks against them.

When it comes to security risks, immigration is just the beginning. Political turbulence in the Maldives – which began

in 2012, when Islamist radicals forced the country's democratically elected president to resign at gunpoint - has enabled China to gain a foothold in India's maritime backyard. This year, China signed a military pact with the Maldives and docked a giant marine research ship in a Maldivian port. Meanwhile, Islamist radicals are expanding their grassroots base, establishing ISIS and al-Qaeda cells on the archipelago.

Mounting economic pressures compound the security risks. Pakistan has repeatedly sought International Monetary Fund bailouts in recent years. And Hasina's overthrow could usher in hard times for the once-booming Bangladeshi economy, as the country's foreign reserves dwindle rapidly. None of this is conducive to regional prosperity. As long as South Asian countries remain plagued by political instability, strong and sustainable economic growth

will remain elusive. The difficulty of maintaining political stability and advancing democratisation can also be seen in Nepal - a country with which India has close cultural and historical ties. Last month, the country swore in its 14th government in just 16 years, led by four-time prime minister, KP Sharma Oli, of the pro-China Marxist-Leninist Party. Oli, who spent years in jail in the 1970s and 1980s for waging war against the state, is Nepal's fifth head of government in five years, having replaced another former communist guer-

rilla, Pushpa Kamal Dahal. All of this puts India, the world's largest democracy and South Asia's geographical hub, in a difficult situation. It must minimise the spillover effects of political and economic instability in its neighbourhood, even as it continues to seek economic and strategic partnerships far beyond its troubled region.

Their reaction suggests that their gestures could serve as a model for how we view international relations, particularly between India and Pakistan. In the triumph of these two great athletes, a simple truth was revealed: a javelin, cast with skill and honour, accomplished what no leader of India and Pakistan could – it brought two nations closer, if only for a moment, in the spirit of the game. The words of the two mothers, acknowledging the achievements of "their sons" as one would a member of one's own family, carry special significance given the fraught history between India and Pakistan.

MCD demolition drive deferred Marathwada to be freehold

New Delhi, August 13: The Municipal Corporation of Delhi Tuesday deferred a demolition drive in Bhalswa Dairy submitting in the high court that it will not launch the exercise till August 16, when the next hearing the matter is due.

'The demolition drive was stopped as a large crowd of protesters assembled at the site raising slogans against the MCD. Since the MCD informed the Delhi High Court that today it will not demolish drive till August 16, we have postponed it till further order," a senior MCD offi-

The counsel representing residents of the dairy colony approached the court later Tuesday apprising it that MCD bulldozers with heavy police force had reached the area for demolition.

A bench of Acting Chief Justice Manmohan and Justice Tushar Rao Gedela said it will take up the matter August 16, when it will also hear a petition regarding the state of dairies

the encroached premises. It had said that enforcement action will be taken against all illegal and unauthorised constructions after the expiry of the deadline and a demolition drive will be car-

civic body gave a three-day ultimatum to defaulters to vacate

In July, the court had directed the authorities to ensure that unauthorised construction in all dairy colonies in the national capital is removed and asked them to take immediate steps for shifting dairies from Bhalswa to Ghogha dairy colony within four weeks.

The court directed the agency to carry out a survey of the Bhalswa Dairy colony to identify misuse of dairy plots that have been converted into dwelling units and shops and are being misused for industrial purposes.

The court was earlier informed by the court commissioner that the condition of all nine designated dairy colonies in Delhi --Kakrola Dairy, Goela Dairy, Nangli Shakrawati Dairy, Jharoda Dairy, Bhalswa Dairy, Ghazipur Dairy, Shahbad Daulatpur Dairy, Madanpur Khadar Dairy, and Masoodpur Dairy -- was "bad".

Perusing the photographs of the dairies, the court had noted that there were large-scale constructions and urbanisation in some of the dairy colonies, including salons, showrooms, gymnasiums, and internet cafes.

It had said the character of the colonies had ceased to be that of dairy colonies as commercial showrooms were operating there and superstructures as high as four storeyed had come up for residential and commercial purposes.

Mumbai, August 13: The Maharashtra cabinet Tuesday cleared a proposal to convert more than one lakh acres of class II land in Marathwada region of the state into freehold, making the occupants complete

Nearly 1.4 lakh acres of land in Marathwada, comprising eight districts, was classified as class II, a government official said.

The class II status was a hurdle for occupants wishing to develop these areas, he said.

Class II occupancy is a conditional holding in which land is given to individuals for various reasons, including as rewards and to religious structures for their maintenance. The demand to convert the land to freehold is nearly 60 years old, he said.

The cabinet's resolution to convert this land into freehold will have a positive impact on the current occupants, the official said, adding that the occupants will have to remit a certain amount to the state government to effect the transition.

The eight districts of Marathwada have 42,710.31 hectares of land identified as 'Khidmatmash' (given for maintenance of religious places) and 13,803.13 hectares of 'Madatmash' land (given as award).

WAYANAD LANDSLIDES 5-member

team begins inspection

Wayanad(Kerala), August 13: A five-member expert team Tuesday began inspecting the landslides-hit areas of Wayanad district including the epicentre of the disaster and collected rock and soil samples for testing.

The team was led by senior scientist John Matthai of the National Center for Geosciences. which has been tasked by the State Disaster Management Authority to inspect the landslide-hit areas in Wayanad's Meppadi panchayat.

It halted its inspection by noon today due to adverse weather conditions in the disaster area, the district administration said in a statement. The inspections will continue till August 15, it added. "The team carried out a detailed inspection of the epicentre of the landslide --Punchirimattom -- and the adjoining areas, and collected soil and rock samples from there,' it said. The team will assess the possible dangers in different parts of the disaster-stricken area and nearby sites. It will also assess how the disaster happened and what phenomena occurred in the landslides, the statement added. After the inspection, the expert team will submit its report to the government and also recommend suitable land use for the area. The team will function under the Disaster Management Authority Act of 2005.



New Delhi, August 13: India will have to wait until June next year for the results of the latest elephant census, as the population estimation has been delayed in some northeastern states,

sources said. Wild elephants are found in forested, hilly tracts across four regions of India: the foothills of the Himalayas in the north, the northeastern states, east-central India, and the Western and Eastern Ghats in the southern parts of the country. A source told PTI that data collection and analysis from the northeast have not yet been completed.

The primary reasons for the delay in the region are "heavy monsoon rains, floods and the limited capacity" of the forest staff, the sources added. The entire process involves creating shapefiles, capacity building, data collection, and data pro-

As a result, the numbers from the latest elephant estimation exercise will only be available by June next year, they said. An official from the Wildlife Institute



of India (WII) said satellite data for elephant population estimation had to be collected during the first phase of the tiger population estimation since the two exercises have been con-

verged now. "But that could not happen in the northeast. We are doing it now. The WII will train the staff in northeast in September-October: They will collect Phase 1 data in November-December and send it to the institute," the official said.

DOCTOR MURDER CBI TAKES OVER PROBE

Kolkata, August 13: Hours after the Kolkata High Court's direction, the CBI Tuesday took over the investigation in the alleged rape and murder of a woman doctor at a state-run medical college in the West Bengal capital.

The agency swiftly completed all formalities following the High Court order asking the state police to hand over the case documents to the central probe agency, officials said.

A team of CBI officials from Delhi along with forensic scientists and medical experts will visit Kolkata Wednesday, they said.

Earlier in the day, the High Court ordered the state police to hand over the case diary to the CBI by 10 AM Wednesday, amid allegations of a botched probe and cover-up as well as protests and strikes by doctors over the incident

The body of the postgraduate trainee, who was allegedly raped and murdered inside a seminar hall of the state-run RG Kar hospital, was found Friday morning. A civic volunteer was arrested in this connection Saturday.

The victim's parents had moved the High Court seeking a court-monitored investigation in the case. Several other PILs were also filed seeking a CBI probe. The preliminary autopsy report suggested that the doctor was sexually abused and murdered. It stated that the victim was bleeding from her eyes, mouth and private parts. There were also injuries on her left leg, neck, right hand, ring finger

The crackdown comes as the Iranian-backed rebels have been targeting shipping throughout the Red Sea corridor over the Israel-Hamas war in the Gaza Strip.

Poland buys 96 **Apache from US**

Warsaw: Poland Tuesday signed a contract with the US to buy 96 AH-64E Apache attack helicopters as it bolsters its armed forces following Russia's invasion of Ukraine. Under the deal with the US government announced by Defence Minister Wladyslaw Kosiniak-Kamysz, the helicopters will provide new combat capabilities in terms of target engagement and reconnaissance, and will replace Poland's post-Soviet Mi-24 helicopters. The deal provides a logistics package, including equipment for helicopter maintenance, airport and hangar equipment and technical support, a training package, and ammunition and spare parts.

Dhaka, August 13: A Bangladesh court ordered an investigation Tuesday into former Prime Minister Sheikh Hasina's role in the death of a grocery shop owner in the capital Dhaka during last month's deadly student-led protests, the complainant's lawyer said.

The case filed by Amir Hamza against Hasina and six others was accepted by Dhaka's chief metropolitan magistrate's court after a hearing, Hamza's lawyer Anwarul Islam said. Magistrate Rajesh Chowdhury ordered police to investigate the case, Islam added. It was the first case filed against Hasina following a violent uprising that killed about 300 people, many of them college and university students. She fled to India August 5 and has been sheltering in New Delhi.

The other accused in the case included Obaidul Quader, the general secretary of Hasina's Awami League party, former Interior Minister Asaduzzaman Khan Kamal and other senior police officials.

Meanwhile, Bangladesh's interim government Tuesday cancelled a national holiday August 15, marking the assassination of the country's founder and deposed Prime Minister Sheikh Hasina's father Bangabandhu Sheikh Muiibur Rahman.

Russia strikes back at Ukrainian forces

Moscow, August 13: Russian forces Tuesday struck back at Ukrainian troops with missiles, drones and airstrikes in actions that one senior commander said had halted Ukraine's advance after the biggest attack on sovereign Russian territory since the

Russian war bloggers reported intense battles across the Kursk front as Ukrainian forces tried to expand their control, though they said Russia was bringing in soldiers and heavy weaponry and had repelled many of the Ukrainian attacks. Russia's defence ministry published footage of Sukhoi Su-34 bombers striking at what it said were Ukrainian troops in the Kursk border region and of infantry storming Ukrainian positions.

out offering further details. The rebels maintain that they have targeted ships linked to Israel, the United States or the UK to force an end to Israel's war against Hamas in Gaza.

The charges of unfair labor practices that the autoworkers union filed with the National Labor Relations Board allege that, during their conversation. Trump and Musk illegally threatened and intimidated workers who engage in protected labor activity, such as

"I mean, I look at what you do," Trump told Musk during the rambling interview. "You walk in, you say, 'You want to quit?' They go on strike. I won't mention the name of the company, but they go on strike, and you say, 'That's okay. You're all gone. You're all gone. So, every one of you is gone. The charges were filed against

Musk did not immediately respond to a request for comment via Tesla or X.

Under the National Labor Relations Act, it is illegal to fire workers for legally going on strike or to threaten them for doing so. The National Labor Relations Board will now investigate whether a labor law violation occurred. If the board determines that violations occurred, it could issue penalties against Musk or Trump.

At the end of the June guarter, Vedanta owned 64.92 per cent stake in Hindustan Zinc while the government had 29.54 per cent.

The court had March 19 said it was deemed appropriate to issue a show cause notice to Ramdev as the advertisements issued by Patanjali, which were in the teeth of the undertaking given to the court November 21, 2023, reflect an endorsement by him.

In its November 21, 2023 order, the top court had noted that the counsel representing Patanjali Ayurved had assured it that "henceforth there shall not be any violation of any law(s), espe-

cially relating to advertising or branding of products manufactured and marketed by it and, further, that no casual statements claiming medicinal efficacy or against any system of medicine will be released to the media in any form.'

The top court had said Patanjali Ayurved Ltd is "bound down to such assurance."

Non-adherence to the specific assurance and subsequent media statements by the firm had irked the apex court, which later issued notice to them to show cause as to why contempt proceedings be not initiated against them.

Indian FMCG firms resume ops in B'desh

New Delhi, August 13: Indian FMCG companies with operations in violence-hit Bangladesh say their business in the neighbouring country is slowly returning to normalcy after being shut for about a week.

Leading FMCG companies including Marico, Dabur, Emami. Pidilite Industries, Britannia and Godrej Consumer Products, have operations in Bangladesh, which recently faced violent clashes leading to a regime change there. Besides, leading **QSR** chain Jubilant FoodWorks Ltd (JFL), a master franchisee of American pizza restaurant chain Domino's, also operates around 30 stores in Bangladesh.

Marico, which has the biggest exposure in Bangladesh, has informed the bourses that its manufacturing operations in the country resumed at normal scale August 11. "Operating conditions in the market have been gradually improving and a large majority of our retail sales force and distributors have been functioning since last week," the Mariwala promoted FMCG maker said.

In Bangladesh, Marico operates in personal care, baby care, edible oil and food segments, and has contributed 44 per cent to the international sales of the company. It has two factories in Gazipur, Dhaka, and five depots.



"We continue to prioritise the safety of our employees, factory workers, distributors and other stakeholders of our business it said adding "we firmly believe that the medium-term prospects of Marico's business in Bangladesh remain intact.'

It had incorporated a subsidiary Marico Bangladesh in 1999. It is a listed entity on the Dhaka and Chittagong stock exchanges and is amongst the top 3 FMCG MNCs in Bangladesh.

Dabur India also said its factory and stockists are operational now after being shut for about a week during the tur-

"We are monitoring the situation closely and we will make all efforts to resume normalcy in operations," said Dabur CEO Mohit Malhotra.

Sensex tumbles amid broad-based selloff

The 30-share BSE Sensex tumbled 692.89 points or 0.87 per cent to settle at 78,956.03. During the day, it tanked 759.54 points or 0.95 per cent to 78,889.38.

The NSE Nifty slumped 208 points or 0.85 per cent to 24,139. A total of 2,676 stocks declined while 1,266 advanced and 84 re-

mained unchanged on the BSE "The domestic market plunged into red terrain in the latter half, amidst mixed global sentiments. Recent IIP data indicates a lacklustre growth in the major manufacturing sector. Persistent selling by FIIs and elevated valuations are further contributing to the decline. All sectors, especially banking, metal were in red, while HDFC Bank declined due to lower-thanexpected passive fund inflows



in the recent MSCI index rejig," said Vinod Nair, Head of Research, Geojit Financial Services.

FRA trades to get boostas LIC enters market

Mumbai, August 13: Investment in a type of bond derivative called forward rate agreements could likely rise in India as the interest rate cycle turns and the country's largest insurer enters the market, traders said.

Forward rate agreements (FRA) are contracts between banks and insurance firms that allow the latter to lock in rates for a future date, protecting them from volatility. Insurers entering such deals can offer guaranteed returns to policy holders.

Central banks globally and in India are poised to cut rates over coming months. Rising demand for debt via derivatives such as FRAs from insurance companies could lead to yields falling and help lower borrowing costs for the government. We are already in talks with

banks to start FRA trades in near future, Siddhartha Mohanty, Life Insurance Corporation's CEO, said in a media briefing last week.

The widening spreads between government bond yields and overnight indexed swaps (OIS) is aiding demand for such instruments, traders said.

Five-year OIS rate has crashed



30 bps since July 1, while yields for bonds maturing in 10 years and above dipped 4 bps-13 bps on rising IIS rate cut bets "At the current level, we should

be seeing more interest in FRAs," Vikas Jain, head of India fixed income, currencies and commodities at Bank of America

FRA trades worth around 113 billion rupees (\$1.35 billion) took place between July 1 and August 2, up nearly 20% from 87 billion rupees in June, clearing house data showed. Traders are anticipating a further jump with LIC entering the market.

Reflecting on this today, a decade later, it's clear that Bernanke's assertion holds true; the events of 2008 serve as a stark reminder of how rapidly and extensively global financial crises can develop in

the twenty-first century. The narrative of the financial crisis is well-known. It all began in 2007 with a decline in the real estate markets of the U.S. and Europe. As housing prices plummeted from California to Ireland, many homeowners struggled to keep up with their mortgage payments, putting pressure on lenders. Due to the interconnectedness of global banking, securities, and funding markets, the fallout quickly affected major financial institutions worldwide.

By late 2008, banks in countries

such as Belgium, France, Germany, Ireland, Latvia, the Netherlands, Portugal, Russia, Spain, South Korea, the United Kingdom, and the United States were grappling with severe crises. Some had already failed, and many more were on the brink of The Great Depression of the

1930s is remembered as the worst economic disaster in modern history—one that resulted in large part from inept policy responses—but it was far less synchronized than the crash in 2008. Although more banks failed during the Depression, these failures were scattered between 1929 and 1933 and involved far smaller balance sheets. In 2008, both the scale and the speed of the implosion were breathtaking. Jhajharia, himself a double gold medallist at the Paralympics, said the Indian contingent would look the carry the momentum of record-breaking performances in the 2021 Tokyo Paralympics and 2023 Hangzhou Asian Para Games.

India had won 19 medals at the Tokyo Paralympics and a historic 111 medals at the Para Asian Games.

'This is the biggest para contingent India has ever sent to the Paralympics. We are very confident about the overall performance and are sure to win more than 25 medals," Jhajharia said here at an event organised by the Paralympic Committee of India (PCI).

India is set to compete in 12 sports, including archery, athletics, badminton, canoeing, cycling, blind judo, powerlifting, rowing, shooting, swimming, table tennis and taekwondo.

India eyeing over 25 Ashwini shocked by SAI disclosure

New Delhi, August 13: India's doubles specialist in badminton Ashwini Ponnappa said Tuesday she received little to no individual financial assistance from the Sports Ministry in the build up to Paris Olympics and even her request for a coach was turned down.

The Sports Authority of India (SAI) had earlier come out with a document, detailing the financial support provided to the

Paris-bound Indian athletes. It mentions that Ashwini was provided ₹4,50,000 under TOPS and ₹1,48,04,080 under annual calendar for Training and Competition (ACTC), which included the procurement of Game Ready recovery equipment, international competitions and sparring partner in the Paris cycle.

"I'm absolutely shocked... I don't mind not getting money but telling the nation that I got money is ridiculous. I haven't received it. Like if you're talking about national camp, then that ₹1.5 crore is spent on all the campers,' Ashwini told this agency.

"I don't even have a specific coach. As for my personalised trainer, I'm paying for him myself. I'm not taking money from anvone. I've played on my own until November (2023). I was included as part of TOPS only after we qualified for the Paris

Olympics," Ashwini added.

Ashwini, 34, has been one of the top Indian doubles players, having won a gold, a silver and a bronze in the Commonwealth Games in 2010, 2014 and 2018 respectively.

Detailing the ₹1.48 crore spending, a SAI source said: The ₹1.48 crore has been spent on her travel, stay, food, competition fee, daily allowance in all the competitions that she participated in as part of the Indian team in the Paris cycle. This money is given to Badminton Association of India as part of ACTC.

Ashwini, who had paired with N Sikki Reddy till August, 2022, ioined hands with Tanisha Crasto in December that year and started playing in international

tournaments from January 2023. A series of good performances helped them seal their Paris berth, after which the duo was included in the TOPS scheme in May this year.

'The Sports Ministry has always supported me. I've been part of the team for years and I'm grateful for the support. The last year I haven't been supported and it's okay. But you can't say I've been given ₹1.5 crore," Ashwini pointed out.

Playing her third Olympics, Ashwini was left in tears after she and Tanisha couldn't win a single match. "I haven't played well. I take responsibility for that. But you can't say I'm getting this big an amount when I haven't even received it,'

disappointing campaign at the Paris Olympics where the country's pugilists returned emptyhanded, the Boxing Federation of India (BFI) invited applications Tuesday for a new foreign coach.

"The main goal in India is to achieve a top result in the upcoming Olympic Games, Asian Games, Commonwealth and other major competitions. The coach should be pysically fit to demonstrate techniques to the athletes.

the advertisement further stated. However, the current foreign coach Dmitry Dmitruk, who was appointed last February, will stay on till the end of his two-year contract. "We have not even discussed about Dmitry. He will serve his contract," a BFI source said.

New Delhi, August 13: Not getting bogged by the enormity of the occasion was foremost on wrestler Aman Sehrawat's mind when he took the mat for the Olympic bronze medal play-off bout. He treated it as another state level competition.

India's voungest individual medal winner at the Paris Olympics, the 21-year-old from the iconic Chhatrasal akhadaa (wrestling academy), gave a sneak peek into his mindset before the biggest bout of his nascent career.

"First I thought, I am in the semifinal and I lost six points. Then it hit me that I've lost six points in an Olympic bout what should I do now? And before I realised, I lost the match. Then



Aman Sehrawat was accorded a huge welcome on his arrival in New Delhi,

and there I told myself that it isn't an Olympic bout and I'm still fighting at the state level," Aman said on his return from Paris

"So, I didn't think of the bout it as an Olympic bronze medal match. Just thought of it as any state level game to get my mind off the occasion," the star wrestler said.

Aman was asked how he managed to cut down weight before his bouts. "It was not a major issue, we already had plans to cut weight and had some 3.5 kg was increased. So I cut the weight overnight and then I went for the weigh in," said the 57kg division grappler, who was found to weigh exactly 100 gram less than the cut-off mark, the same quantity that famed Vinesh Phogat had exceeded.

Aman was candid enough to state that he is very happy at becoming the youngest Indian to win

an Olympic medal. "Feels great. Now the aim is to change the colour of the medal at the next Olympics (in Los Angeles in 2028). I will work hard for it," he said.

The bronze winner also ac knowledged the contribution of Tokyo Olympics silver medallist Ravi Dahiya, who was his mentor: "Ravi Dahiya has played a huge role in my journey. We followed his footsteps in training and got inspired by him," Aman stated. He also thanked his brother for taking care of him after he lost both his parents at ঽ a tender age.

"My journey was indeed difficult but my brother Sagar took care of me. Not for once did he let me feel the parental void. He took good care of me," Aman
