### Maiden Paralympic gold for Nitesh

Paris, Sept 2: India's Kumar Nitesh clinched his maiden gold medal at the Paralympics, defeating Great Britain's Daniel Bethell in a gripping men's singles SL3 badminton final here Monday.

The 29-year-old from Haryana showcased incredible resilience and tactical brilliance, overcoming Tokyo silver medallist Bethell in a nail-biting contest that lasted 80 minutes, with the final scoreline reading 21-14, 18-21, 23-21.

"I still don't feel it. May be when I go to the podium and the national anthem is played. it will sink in," Nitesh said after

## SC raps 'bulldozer justice'

New Delhi, Sept 2: With several state administrations flattening the houses of those involved in criminal cases with bulldozers, the Supreme Court questioned Monday how can anybody's residence be demolished just because he is an accused. A bench of Justices BR Gavai and KV Viswanathan said it will lay down guidelines on the issues that would be enforceable across the country.

"How can anybody's house be demolished only because he is an accused? Even if he is a convict, still it can't be done without following the procedure as prescribed by law," the bench stated.



We propose to lay down certain guidelines on a pan-India basis so that concerns with regard to the issues raised are taken care of

Appearing for a one of the petitioners, senior advocate Dushvant Dave sought a direction from the apex court to ensure that 'bulldozer justice' is not

meted out across the country. Addressing the bench, Solicitor General of India, Tushar Mehta submitted that no immovable property can be demolished just because the accused is involved in a criminal offence. "Such demolitions can only happen if the structure is illegal," Mehta pointed out. He also argued that the matter is being misrepresented before the court.

"If construction is unauthorised, fine. There has to be some streamlining. We will lay down a procedure. You are saying demolition only if violation of municipal laws. There is a need for guidelines, it needs to be documented," Justice Gavai observed.

The solicitor general said the pe-

titioners have projected the issue as if houses were demolished only because some people committed an offence. Mehta said he can show that authorities had issued notices well in advance before demolition was carried out.

Stressing on the need for formulating guidelines on the issue. the bench said it was necessary to ensure that neither an individual takes advantage of a loophole nor authorities rely on lacunae. "As they said, a pious father can have recalcitrant son and vice-versa, but this is no way to go about it," the bench observed.

Dave said, "Let a statement be recorded that across the country, bulldozer justice will not be meted out to people anymore.'

## Student suicides up 58%: CM

Bhubaneswar, Sept 2: Odisha has witnessed a 58 per cent rise in student suicides in three years till 2023, Chief Minister

Mohan Charan Majhi told the Assembly, Monday.

In a written response to a question from BJD member Dhruba Charan Sahoo, the Odisha CM, who also holds the Home portfolio, said 119 students in the state ended their lives in 2021, while the number went

up to 173 in 2022. The year 2023 saw 189 students dying by suicide for various reasons.

The state has witnessed more

than boys. Altogether 218 boys died by suicide in the three years, while the number was 263 for girl students, Majhi informed.

The CM said the state has reported 17,778 suicide cases in three







'Bangladeshi infiltrators being identified'

Bhubaneswar, Sept 2: The state government has asked Collectors and superintendents of police (SPs) in all districts to identify Bangladeshi infiltrators, Chief Minister Mohan Charan Majhi told the Assembly Monday.

In a written reply to a question from BJP MLA Bhaskar Madhei, Maihi said a direction has been issued to form committees comprising officers of tehsils, blocks and police stations to identify the infiltrators in various places, especially Kendrapara district where the majority of the 'illegal entrants' reportedly live.

In another statement to the House, the CM said a total of 3,740 Bangladeshi infiltrators were living in the state illegally

Of them, 1,649 live in

Kendrapara district, followed by 1,112 in Jagatsinghpur, 655 in Malkangiri, 199 in Bhadrak, 106 in Nabarangpur, 17 in Khurda district's Bhubaneswar and two in Bargarh district, he said.

The proposal to send them back to their country is under consideration of the government, Majhi informed the Assembly

## Women fisherfolk protecting forests for over 2 decades

Puri, Sept 2: In the remote coastal village of Sahan at the Devi river mouth in the district, a group of women fisherfolk has been quietly making history for the past 25 years.

The 'Maa Gangadevi Jungle Surakhya Committee', led by these resilient women, has become a beacon of community-led

forest protection. Members of the committee, along with their families, rely on trading fish, dry fish in particular, to sustain their livelihoods. However, despite their unprivileged background and limited formal education, they have shown unparallel commitment towards nature conservation.



Since 1999, in the aftermath of the devastating Super Cyclone, they have been protecting the casuarina and mangrove forests surrounding their village. This initiative is carried out through a routine group system known as 'Thenga Pali' where women, armed with wooden sticks, take turns patrolling the forests.

Each morning, the committee members venture into the forest carrying food and water for the day. Their mission is to guard the casuarina and mangrove stretches from any threats—from illegal logging or other harmful activities. They do not hesitate to confront those who pose a danger to the forests,

while working closely with local Forest department to ensure the necessary actions against the trespassers.

In addition to protecting the forest, they also lead beach cleanup drives at the Devi river mouth, Sagan beach, and Jahania beach—crucial breeding sites for the vulnerable Olive Ridley

Though this communitydriven initiative has not been officially recognised by any government policy, its impact is undeniable. The women of the committee have nurtured a legacy of forest protection spanning across generations.

Abali Behera, a committee member, said, "We know the great value of our native forests and mangrove ecosystems. They protect us from the strong winds that come from the sea. We are committed to safeguarding them for our safety.

Another core member, Nabi Dei, highlights the vital role of mangroves in their lives. "Our homes and the river are separated only by a soil wall. The mangroves make that wall stronger. My family depends on fishing and collecting crabs, which thrive thanks to the mangroves' presence. We protect them for our safety and the safety of future generations.'

The committee has also been playing an active role in collaborating with local administration and various stakeholders in forest restoration and conservation initiatives.

### 4 bridges at Bhadrak-Vizianagaram Rail Section

Bhubaneswar, Sept 2: The construction of four important bridges over the rivers Mahanadi, Birupa, Kathajodi and Kuakhai is set to begin as part of the strategic third line expansion between Bhadrak-Vizianagaram Rail Section, the Ministry of Railways announced Monday.

The landmark project will be part of government's commitment to enhancing rail connectivity in eastern India, railway officials said.

East Coast Railway (ECoR) sources said the tender has been invited for construction of four important river bridges between Nergundi and Barang, in a

stretch of 22 km. The project involves the construction of critical bridges on an Engineering, Procurement, and Construction (EPC) mode. The estimated cost of the EPC tender for construction work stands at ₹996.60 crore, reflecting the scale and importance of

The Mahanadi Rail Bridge, in particular, holds historical significance. The first Mahanadi Rail Bridge, completed in 1899, was an engineering marvel of its time, featuring 64 spans of 30 meters each.

The second Mahanadi Rail Bridge, commissioned in 2008, was constructed at a cost of ₹120

the bridge is designed to accommodate trains travelling at speeds of up to 160 km per hour and is engineered to withstand seismic activities.

gions of India," officials said. The tetravalent dengue vaccine strain (TV003/TV005), originally developed by the National Institutes of Health (NIH), USA, has shown promising results in preclinical and clinical trials worldwide," they said.

## Scientists unlock secret to conversing with sleeping mind Findings suggest that it

may be possible for some people to make decisions from inside a dream and communicate them to the outside world

eople have pondered whether dreams have a purpose throughout human history. Modern scientists are fascinated with this question For a long time the science of

dreams has oscillated between fringe research and the mainstream. But creative study designs and new technology are transforming it into an exciting and serious research niche. --Lucid dreams

In 2021 an international study showed that two-way communication between a lucid dreamer and a researcher in the lab was built on this by training lucid dreamers to control a virtual car from within their dreams.

The 12 dreamers in the experiment made slight muscle twitches, which sent a signal to a computer to make the virtual vehicle move forwards or turn. Signals were sent back to the dreamer to inform them of obstacles to try and avoid. Some could move the car well, but others, no matter how hard they tried, could not.

While fascinating, it is still unknown how such technology could be used in everyday life. But the findings suggest that it may be possible for some people to make decisions from inside a dream and communicate them to the outside world.

Why do we dream?

Sleep and dreams researcher Mark Blagrove from Swansea



University thinks dreams were meant to be shared socially and evolved in humans to enhance emotional intelligence and empathy. Since 2016, Blagrove has collaborated with artist Julia Lockheart in a dream discussion and illustration group. An audience member is invited to share a recent dream. Blagrove leads the discussion, while Lockheart sketches an inter-

pretation of the dream onto the pages of Sigmund Freud's book

The Interpretation of Dreams. His 2019 research paper showed that discussing a dream in this way can lead to increased empathy between dream sharer and listeners. Blagrove argues this could have been valuable to ancestral survival in forming significant connections with others.

dream have begun to emerge in recent years too, and some were discussed at a panel in June 2024 at the International Association for the Study of Dreams (IASD) annual conference. For example, the embodied cognition theory of dreaming, proposes that dreams prepare us for the cognitive actions of ordinary wak-

Insights from long dream series

Michael Schredl of the University of Mannheim in Germany is arguably the most prolific dream researcher today, having published hundreds of articles and books since his career began in the 1990s. At the IASD conference, he gave a keynote talk analysing over 12,000 of his dreams.

Overall, the patterns seemed to support the continuity hypothesis of dreaming - that our

dreams are influenced by events and concerns that are happening in our waking lives.

Schredl believes he is one of the first people to look at weather patterns in dreams. He noticed a steady decline over the years of ice, snow and hail in his dreams. Interestingly, this was similar to the documented declining number of "ice days" (days when the temperature was below 0°C for 24 hours) in Germany since he has been keeping a dream journal.

Another interesting pattern was references to money in dreams. When the Deutsche Mark was the prevailing currency, it occasionally showed up in his dreams over the years, but when the German currency changed to the Euro in 2002, the number of Deutsche Mark references was replaced by references to the Euro.

## Couple killed in tusker attack

Khaprakhol, Sept 2: In a tragic incident, a couple was killed in a tusker attack at Chabripali village of Bhanpur panchayat under this block of Harishankar forest range in Bolangir district late Sunday night. The deceased were identified as Nilambar Bariha, 56, and his wife Yashobanti Bariha, 54.

According to reports, the family of Nilambar was residing in a hut in the midst of their farmland near Chabripali village. All the family members went to sleep after dinner, Sunday. In the dead of the night, a wild tusker suddenly entered the village around 2am in search of food and broke open their house.

The family members shouted for help but the tusker attacked the couple, flung them on air and trampled them to death. Other family members including their son, daughter-in-law, granddaughter and grandson managed to protect themselves from the elephant attack and fled the spot. Other villagers managed to drive away the elephant into the nearby forest.

On being informed, Forest department personnel, fire brigade team and police reached the spot and sent the bodies for postmortem to Khaprakhol hospital. After post-mortem, police handed over the bodies to their family members. A case (No-11/2024) of unnatural death was registered with Khaprakhol police who began an investigation, said Khaprakhol PS IIC, Narendra Chhatar.

### Containers of sunken ship \_ wash ashore at Satabhaya §

Rajnagar, Sept 2: Two shipping containers of a sunken ship washed ashore Satabhaya beach in Gahirmatha Marine Sanctuary in Kendrapara district Monday, officials said.

It appeared that both the containers were lost at sea after a cargo vessel sank in the sea last week, they said.

Labels on the containers confirmed that both were owned by logistics firm ITT Lines Private Limited, Kolkata.

MV ITT Puma, a Mumbai-registered general cargo vessel, was en route to Port Blair from Kolkata when it sank August 26 around 90 nautical miles south of Sagar Island in West Bengal.

Stormy weather caused the shipping containers to drift from the sunken ship to Satabhaya beach, the officials said.

Police and Forest officials rushed to the beach and cordoned off the area and warned people to keep a safe distance from the containers.

The authorities were still investigating what items were in the containers

Most of the items in the containers were washed away as doors were opened due to the impact of waves, Divisional Forest Officer (DFO) of Bhitarkanika National Park, Sudrashan Gopinath Yadav, said.

All the containers of the sunken ship contained household materials. The ship was sailing from Kolkata to Port Blair when the cargo vessel capsized, an official of ITT Lines Private Limited, Kolkata said.

The Indian Coast Guard res cued 11 crew members from the sunken ship August 26 and brought them to Paradip the next day.

### **Ceasefire Now**

assive protests swept through Tel Aviv, Jerusalem and other Israeli cities Sunday night as tens of thousands vented their anger after the bodies of six hostages captured by Hamas on 7 October, last year were discovered in Gaza over the weekend. The huge scale of the protests with over five lakh participants, as per some media estimates, will hopefully pressurise Prime Minister Benjamin Netanyahu and his Right-wing government to go for a ceasefire and hostage release deal with the Palestinian militant outfit. There are calls from within the cabinet, for example from Defence Minister Gallant, for Netanyahu to change course as also for holding fresh elections in the country as its longest serving prime minister's approval ratings are at their lowest.

The bodies of Carmel Gat, Hersh Goldberg-Polin, Eden Yerushalmi, Alexander Lobanov, Almog Sarusi and Ori Danino were found from a tunnel in the city of Raffah in southern Gaza even as a polio vaccination drive was launched in the war-ravaged Palestinian territory over the weekend. The hostages were shot multiple times from a close range. Of them, Goldberg-Polin, an American-Israeli, and four others were abducted from a music festival on 7 October, while the sixth was captured from a nearby farming community.

Netanyahu, despite facing immense pressure to end the war which has now been going on for close to 11 months, remained steadfast. "Whoever murders hostages - does not want a deal," he said. On the other hand, senior Hamas officials blamed Israel's refusal to agree to a ceasefire for the fatalities. "Netanyahu is responsible for the killing of Israeli prisoners... The Israelis should choose between Netanyahu and the deal," senior Hamas official Sami Abu Zuhri told news agency

There are 101 more Israeli hostages held by the Hamas militant group. It is estimated by Israeli authorities that a third of them have been killed. Israelis are polarised over the fate of their hostages, leading to one of the most distressing political conflicts in the nation's history. Surveys indicate that a significant number of Israelis desire the return of hostages, even if it means exchanging them for Palestinian prisoners and agreeing to a ceasefire, which is indeed the need of the hour. They have lost faith in Prime Minister Benjamin Netanyahu, feeling that he has displayed a dismissive attitude towards the plight of the hostages and the suffering of their families. While this is the view of the majority of Israelis, an influential minority believes that the hostages should be regarded as a necessary sacrifice to fulfil the objectives of the war, and the government evidently intends for those objectives to encompass the ultimate conquest and settlement of Gaza.

Netanyahu wants the war to continue to that end as he is desperate to save his own political career. He has so far paid no heed to the multiple calls for a ceasefire from various stakeholders, including from the United States, Israel's biggest ally. Unsurprisingly, this is what most despotic leaders the world over, elected or unelected, do when faced with a crisis. They take refuge in nationalism and war and in the process bring untold miseries to their victims who are mostly their own citizens.

Israel's ground and aerial offensives in Gaza have so far claimed over 40,000 lives, mostly civilians, and ousted most of the enclave's 2.3 million residents from their homes. A ceasefire appears to be the only hope for peace in the region and that seems to be the elusive dream.



## **UNIVERSAL BASIC INCOME**

n the Economic Survey of 2016-17, the concept of Universal Basic Income (UBI) was discussed as a potential solution to reducing poverty and income inequality. It was put forth as a radical idea whose time had come. The Survey report estimated that the cost of a direct cash transfer to every Indian of Rs 7260, equal to the then poverty line number would entail an annual cost of 4.9% of GDP. This was unthinkable and daunting given the fiscal resources available to the government. So UBI was a distant and elusive goal. However, the concept of direct cash transfers has gained immense popularity. The Direct Benefit Transfer (DBT) was rolled out in January 2013 because it eliminates leakage, is timely, is transparent and helps financial inclusion.

The no frills Jan Dhan bank accounts, Aadhaar number identification and mobile are the JAM enablers of DBT. All three have become ubiquitous making it easier for the spread of DBT which can be in the form of cash or in kind. As per the DBT website there are 315 schemes across 53 ministries being implemented by the Central government alone, which cumulatively have disbursed 38 trillion rupees so far, of which 3 trillion was just in the last fiscal year. The total number of unique beneficiaries who receive cash was about 700 million in 2023-24. The concept of DBT is not confined to cash alone, since the free distribution of food grain of five kilo per person per family per month is also considered an in-kind DBT. The number of beneficiaries for such in-kind DBTs was more than 1 billion in 2023-24. The distribution of in-kind benefits such as free food grain or a cooking gas cylinder also entails the cost of delivery. But DBT of cash is directly into the bank account already created by JDY. Hence the cost of transfer is minimal. Which is why cash DBT has caught on in popularity,

and many states are also using it. If you include the variants of DBT implemented by various states, the total number of

schemes could surpass 450. The latest example of a cash DBT is Maharashtra's Ladki Bahin Scheme (LBS). This gives 1500 rupees to every woman between the age of 21 and 65 who is domiciled in the state, not a government employee or taxpayer and whose family income is less than Rs 2.5 lakh per annum. Since it puts conditions for eligibility it cannot be called universal. But more than 2 crore applications have been received already. The Chief Minister has promised to double the benefit if re-elected. The estimated cost to the state's exchequer is Rs 46,000 crore per year. The objective of this cash transfer scheme is to empower women and help them come out of poverty. So, it is not unlike the objective of UBI. It was inspired by the Ladli Behena Scheme (LBS) launched in neighbouring Madhya Pradesh in January 2023, which received an enthusiastic response. That too was aimed at providing financial assistance to women, to empower, and to have resources for skill development and training. Interestingly, it was pitched only to married (or divorced or widowed) women. Madhya Pradesh had launched the Ladli Lakshmi scheme in 2007 which was emulated by six other states. Unlike LBS which is for financial empowerment, the Lakshmi scheme was aimed at the girl child and to reduce the skew in the sex ratio. The total benefit to the girl given as deferred payment on reaching the age of 21

was more than Rs 1 lakh. If you count the various cash transfer schemes for girls and women across different states of India, it adds up to a significant amount. To that you can add in-kind benefits like free tuition, free bicycles, or free bus tickets and so on, which are being implemented in a few states. This does begin to get closer to universal income focused on the female gender. We need to then go back to the UBI debate and examine its viability in the present context, after eight years of being introduced in the Economic Survey.

For UBI to be fiscally viable, many existing schemes have to be cut down or replaced. For instance, the cash transfer to farmer households (PM Kisaan) will be subsumed in UBI. The

less the conditionality attached the lesser the cost and better the chances of it being effective. The approach should be opt-out rather than opt-in. So richer folk who prefer to remain out of UBI have to voluntarily opt-out, otherwise by default everyone is in. Universal coverage simplifies administration and reduces exclusion errors. Of course, the benefit ends up also going to individuals who do not need such assistance, as they may be quite well off. Of course, as the Economic Survey too pointed out, the cash based UBI can be potentially inflationary. And in any case UBI may need to be enhanced every year due to inflation indexation. This aspect makes the UBI less attractive, because if the inflation burden rises faster than the growth of taxes, then at some point it becomes unsustainable.

One practical approach is to roll out UBI like a targeted public distribution system (TPDS). which only focuses on backward areas and districts. A pilot UBI can be rolled out that targets only the most vulnerable groups, such as the elderly, poor women (like in LBS of Maharashtra or MP), or indigent and the disabled. It could be tried out in different States. The learning from such a pilot can be used to better design a UBI which is affordable and ef-

There remains the philosophical issue whether basic income is a right. Since we have enacted rights or have given de facto entitlement to food, education, rural employment, this idea of basic income, especially to the most vulnerable, is but a natural extension. Given the proliferation across different states of various cash transfer and other free in-kind benefits schemes for girls and women, we are already marching toward a modified form of UBI.

## China's rise and imminent fall

raising concerns worldwide. It is easy to see why: China accounts for nearly onethird of the world's manufacturing value-added, and one-fifth of global manufacturing exports. But there is good reason to believe that the decline of China's manufacturing sector is imminent.

To understand what is happening now in China, it is worth recalling Japan's recent history. After World War II, Japan's manufacturing sector grew rapidly, thanks largely to access to the massive US market. But the 1985 Plaza Accord (which boosted the yen's value and weakened Japanese exports), together with an aging population and a shrinking labour force, reversed this trend.

From 1985 to 2022, the share of Japanese goods in US imports dropped from 22% to 5%, and Japan's share of global manufacturing exports declined from 16% to 4%. And the number of Japanese companies on the Fortune Global 500 list dropped from 149 in 1995 to just 40 today.

China has followed a similar upward trajectory in recent decades, but China's manufac-

hinese overcapacity is turing rise was even more de- China's government, however. China is looking increasingly pendent on the US market. Japan's imports from the United States equaled 51% of its exports to the US in 1978-84, compared to a 23% share for China

Chinese family-planning policies are largely to blame for this imbalance. Typically household disposable income would account for 60-70% of a country's GDP, in order to sustain household consumption of around 60% of GDP. In China, however, the one-child policy – which was in place from 1980 until 2015 – limited household earnings, encouraged high savings, and constrained domestic demand.

As a result, Chinese household disposable income dropped from 62% of GDP in 1983 to 44% of GDP today, with household consumption falling from 53% of GDP to 37% of GDP. In Japan, by contrast, household consumption equals 56% of GDP. One can look at it this way: if wages would normally amount to \$60-70, Chinese workers receive only \$44 and have just \$37 of spending power, whereas Japanese workers have \$56 of spending power.

has plenty of financial resources, which it uses to support industrial subsidies and investment in manufacturing. Moreover, because China's manufacturing sector offers high returns, international investors are willing to channel capital toward it. Add to that a surplus of about 100 million workers, and excess capacity is difficult to avoid.

Given insufficient demand at home, China's only option for reducing its excess capacity and creating enough jobs for its population is to maintain a large current-account surplus. That is where the US comes in: the share of Chinese goods in US imports rose from 1% in 1985 to 22% in 2017. In 2001-18, the US accounted for three-quarters of China's trade surplus.

Beyond losing the American market, China is losing some of its own manufacturing companies, which are shifting part of their production to countries such as Vietnam and Mexico, to avoid US tariffs. This partial transfer augurs a wider withdrawal, much like that faced by Japan's manufacturing sector as it fell into decline.

like Japan for two other reasons. First, its workforce is rapidly shrinking and aging.

Second, China's services sector is set to squeeze manufacturing. As China's government seeks to increase the GDP share of household disposable income. Chinese demand for US goods will rise, and some manufacturing workers will shift to services, which is also where China's rapidly growing pool of college graduates will find employment.

The decline of manufacturing might not happen as fast as it did in Japan, because China has a larger domestic market and a more complete industrial ecosystem, and because it is investing heavily in artificial intelligence and robotics, which could deliver productivity gains. But decline is both inevitable and irreversible. Unfortunately for the US, however, this will not necessarily bring about a revival of domestic manufacturing.

Kishtwar/Jammu, Sept 2: Mohammad Sidiq, a shepherd, is walking back to his native Kathua district in Jammu and Kashmir with his herd of sheep and goats from the high-altitude meadows of Kishtwar, months ahead than intended.

Like him, many members of the pastoralist Bakerwal community are making the journey two months ahead of the sched uled seasonal migration to cast their votes in the Jammu and Kashmir Assembly polls, taking place for the first time since the abrogation of Article 370 of the Constitution in 2019.

Gujjars and Bakerwal families migrate to the upper reaches of Jammu and Kashmir along with their cattle at the beginning of summer in search of greener pastures and return to the grazing grounds in the plains

ahead of winter. "We are returning home early this season to cast our votes. We are originally from Kathua district and come to Kishtwar every year to graze our cattle in April,' Sidiq told PTI upon reaching Chowgam grounds in the Kishtwar town from the remote Dachhan area.

Jammu and Kashmir is going to polls in three phases --September 18, 25 and October 1. The counting of votes is scheduled for October 8.

The six Assembly segments in Kathua district along with 34 other seats spread across north Kashmir districts of Kupwara, Baramulla and Bandipora and Jammu region's Udhampur, Samba and Jammu districts are going to polls in the last phase.

'We will vote for a candidate who can take care of us, especially during our bi-annual migration," he said.

Mohd Shafi stressed that everyone should exercise their voting rights to form a popular gov-

In December last year, the Supreme Court directed the restoration of statehood in Jammu and Kashmir at the earliest and to hold elections to the Assembly by September 30, 2024.

"Our community is faced with many issues. Educationally, economically and socially we are backward compared to other sections of society. We hope the new government will focus on our upliftment," he said.

### **BJP** releases 4th list for J&K polls

The list was released on the approval of the party's central election committee.

The Union Territory of Jammu and Kashmir, which has a 90-member assembly, is going to polls in three phases September 18, 25 and October 1. These six seats will vote in the second phase.

## BJP MLA urges Shah to withdraw 60K Central forces from Manipur

Imphal. Sept 2: A day after two persons were killed and 10 others were injured in an attack by suspected Kuki militants in Imphal West District, influential BJP MLA Rajkumar Imo Singh Monday requested Union Home Minister Amit Shah to withdraw 60,000 Central forces from the state claiming "they are not yielding peace"

Singh, who's the son-in-law of Chief Minister N Biren Singh, wrote to the Home Minister stat ing that the presence of around 60,000 Central forces in Manipur "is not yielding peace, thus it's better to remove such forces who are mostly present as mute spectators".

'We are pleased with the action to remove certain units of Assam Rifles who were not cooperating with the state government and the public, but if the presence of Central forces cannot stop the violence, it is better to remove them and allow the state forces to take charge and bring peace in Manipur," the MLA said in the letter. Noting that the Central government has to take more stringent measures against armed militant/insurgent groups,



the lawmaker said the militants violated the ground rules of Suspension of Operation (SoO).

The Home Ministry has to abrogate the SoO pact against these groups who are constantly spreading violence, said Singh, a threeterm MLA from Sagolband Assembly constituency in Imphal West district.

A total of 23 underground outfits under two conglomerates eight under United Peoples' Front (UPF) and 15 under Kuki National Organisation (KNO) – signed the Suspension of Operation (SoO) agreement with the government of India in August 2008

Demanding to investigate the fundings and supply of arms and ammunition to the militant outfits. Singh said, "Earlier also I said that a mere ethnic conflict

### PDP banks on Iltija Mufti to retain party's bastion in J&K

Srinagar, Sept 2: The PDP has banked on Iltija Mufti, the daughter of party chief Mehbooba Mufti and a third-generation member of the family, to retain its Srigufwara-Bijbehara Assembly seat, a PDP bastion

The Srigufwara-Bijbehara Assembly seat, earlier known as the Bijbehara constituency before the delimitation exercise of 2022, is going to polls in the first phase of Assembly elections in Jammu and Kashmir September 18.

This constituency in south Kashmir's Anantnag district has the least number of candidates -- just three -- of all the 24 constituencies that will go to polls three weeks from now.

The other two candidates in the

fray are two former MLCs --National Conference (NC) leader Bashir Ahmad Shah and BJP leader Sofi Mohammad Yousuf. If 37-year-old Iltija Mufti

emerges victorious, it would strengthen the PDP's -- and the Mufti family's -- hold on this bastion that they have made their own since 1996.

Mufti Mohammad Sayeed, who founded the PDP in the latter part of his long political ca-

reer, started his electoral foray with a win from the Bijbehara seat in 1962 as candidate of the NC faction headed by Ghulam Mohammad Sadiq.

PDP president Mehbooba Mufti also started her electoral politics from Bijbehara, winning on Congress ticket. She resigned from the Assembly when the Senior Mufti decided to part ways with the Congress and floated his own regional

Mufti loyalist and senior PDP leader Abdul Rehman Bhat won four consecutive elections from Biibehara till 2014, the last Assembly polls held in Jammu and Kashmir. Bhat has been given the party ticket from the Shangus-Anantnag West constituency this time.

National Conference candidate will be hoping to break the PDP stranglehold on this constituency which was represented by his father Abdul Gani Shah

from 1977 to 1990 The oldest political party of Kashmir has invested heavily in Bashir Ahmad Shah, giving him the party ticket several times even though he lost every time. He was even made an MLC when the NC formed a coalition government with the Congress from 2009 to 2014.

Hyderabad/Vijayawada, Sept 2: Torrential downpour in Telangana and Andhra Pradesh left 31 persons dead, battered roads and rail tracks snapping connectivity, submerged thousands of acres of agricultural crops and left people scampering for daily needs as rescue agencies were pressed into rescue and rehabilitation efforts.

The two Telugu speaking states were reeling under the impact of the rains Monday, as 16 persons were killed in Telangana and 15 others in the neighbouring Andhra Pradesh, which particularly bore the brunt of the rain

A portion of gravel under the railway track near Kesamudram in Telangana was washed away due to floodwaters.

Nearly 4.5 lakh people were affected in Andhra, even as heartwrenching scenes of people struggling to ensure essentials, including milk were witnessed in the worst affected Vijayawada. The most affected districts included NTR. Guntur. Krishna. Eluru, Palnadu, Bapatla and Prakasam, said an official press

Twenty SDRF and 19 NDRF teams are engaged in relief and rescue operations.

Life was completely thrown out of gear in Vijayawada following torrential downpour over the past three days and with more than 24 hours of power cuts in several parts of the city.

Visuals aired on local TV news channels showed a woman lamenting to Chief Minister N Chandrababu Naidu that people were stranded for two days in Aiit Singh Nagar in Vijayawada without drinking water. She complained no boat came to their rescue while another man standing in waist deep waters begged Naidu, who was touring the flood-affected areas for the third time on a boat, to understand their predica-

People were seen wading through floodwaters carrying their children on shoulders to safety while an old woman lying on a mattress was seen being shifted over floodwaters by two persons. Some people tried to help themselves through the deluge using a rope

As people waded through the floodwaters, a few of them held on to some basic necessities in their hands and a large queue was formed at one of the floodaffected places to collect milk

sachets and food packets.

At one such place, a flood victim complained they did not have milk since Sunday morning and alleged no help came their way from the government.

Internet and mobile telephone connectivity were disrupted and long traffic snarls disrupted normal life. Connectivity to Hyderabad was affected. Transportation within Vijayawada city and its vicinity was chaotic.

At Prakasam Barrage, 11.3 lakh cusecs of floodwaters were discharged by 8 am Monday.

an immediate Central assistance of ₹2,000 crore.

### **CCEA nod to Mumbai-Indore rail line**

New Delhi, Sept 2: The Cabinet Committee on Economic Affairs Monday approved a 309-kilometre new line project, providing the shortest rail connectivity between the two major commercial hubs of Mumbai and Indore, Union minister Ashwini Vaishnaw

The total cost of the project has been pegged at ₹18,036 crore and it will be completed by 2028-29, the minister said.

The project will generate direct employment for about 102 lakh man-days, or what Vaishnaw described as "human days", during the construction.

Prime Minister Narendra Modi said in a post on X, "Today's Cabinet decision will improve connectivity between Mumbai and Indore. In addition to boosting commerce, it will also provide employment opportunities to several people.

An official statement later said the new line between Indore and Manmad would provide direct connectivity and improve mobility, ensuring enhanced efficiency and service reliability for the Indian Railways.

The project is a result of the PM-Gati Shakti National Master Plan for multi-modal connectivity, which has been possible through integrated planning and will provide seamless connectivity for the movement of people, goods and services, it said.

### Maliwal assault case: SC grants bail to Kejriwal aide Bibhav Kumar

New Delhi: The Supreme Court Monday granted bail to Delhi Chief Minister Arvind Keiriwal's aide Bibhay Kumar in the Swati Maliwal assault case. A bench of Justices Surya Kant and Ujjal Bhuyan directed that Kumar will not be reinstated as a personal assistant to Keiriwal or given any official assignment in the chief minister's office. The top court also restrained Kumar from entering the chief minister's residence till all witnesses have been examined. Kumar allegedly assaulted Maliwal, a Rajya Sabha MP, May 13

at Kejriwal's official residence. While denying him bail, the high court had said the accused enjoys "considerable influence" and no ground has been made out to grant him the relief.

### Shambhu border: SC forms committee to resolve grievances of farmers

New Delhi: Observing that the issue of farmers' protest should not be politicised, the Supreme Court Monday constituted a high-powered committee headed by former Punjab and Haryana High Court judge Justice Nawab Singh to amicably resolve the grievances of protesting farmers at the Shambhu border. A bench of Justices Surya Kant and Ujjal Bhuyan directed the committee to convene its first meeting within a week and asked the panel to reach out to the agitating farmers to immediately remove their tractors, trolleys etc. from the Shambhu border between Punjab and Haryana to provide relief to commuters. Both the Punjab and the Haryana governments will be free to give suggestions to the committee, it added.

### Excise policy 'scam': SC grants bail to Vijay Nair in PMLA case

New Delhi: In a relief to former AAP communication in-charge Vijay Nair, the Supreme Court Monday granted him bail after nearly 23 months of incarceration in a money laundering case stemming from the alleged Delhi excise policy scam, observing that liberty is stringent laws. The Calcutta High Court on Friday granted bail to Paschim Banga Chhtra Samaj leader Sayan Lahiri. Paschim Banga Chhatra Samaj, an unregistered student group, was one of the two organisations that gave the call for the August 27 'Nabanna Abhijan'. Lahiri was arrested August 27 evening for playing an active role in leading the rally which, the police said, turned violent, causing destruction of public and private property and attacks on police officers. Acting on a plea by Lahiri's mother Anjali seeking quashing of proceedings against him and grant of bail, the Calcutta High Court had on Friday ordered his release from police custody by 2 pm Saturday.

## Forest dept using dolls to bait man-eating wolves

**THE MAN-EATING WOLVES HAVE UNLEASHED A REIGN OF TERROR KILLING SEVEN KIDS AND ONE WOMAN**

Bahraich (UP), Sept 2: In a bid to catch wolves that have unleashed a reign of terror in this district of Uttar Pradesh, the Forest department here has initiated an innovative effort of using colourful teddy dolls soaked in children's urine as a bait to capture them, a senior forest official said Monday.

Over the past few months, the Bahraich district has been plagued by a series of attacks by man-eating wolves targeting the children and villagers. So far seven children and one woman have lost their lives in wolf attacks. Thirty others have been mauled an injured. The latest attack took place Sunday night in which a

2.5-year-old girl was killed.

These dolls have been strategically placed near the riverbanks, close to the wolves' resting places and dens, and are being soaked in children's urine to simulate the natural human scent.

'The wolves are constantly changing their locations. Typically, they hunt at night and return to their dens by morning. Our strategy is to mislead them and lure them away from residential areas towards traps or cages placed near their dens,' divisional forest officer Ajit Pratap

Singh said. "Since these animals have primarily been targetting children, we have introduced large teddy dolls dressed in colourful clothes, soaked in

children's urine, to create a false sense of human presence near the traps. The natural human scent may attract the wolves closer to the traps," the officer

Senior IFS officer Ramesh Kumar Pandey, who has extensive experience working in the Terai forests and is currently serving as the Inspector General of Forests in the Ministry of Environment, said that wolves, iackals, foxes, covotes and both domestic and wild dogs belong to the canid species. They al-

ways tend to attack in packs and targets humans or animals that are smaller in size. In recent months, a

pack of wolves in the Mahsi Tehsil of Bahraich has become increasingly aggressive, with attacks intensifying

### Wolves maul to death child, injure women

Atwo-year-old girl was killed and two women injured in three separate wolf attacks in the Mahsi area of Bahraich district while reports of suspected animal attacks were also received from neighbouring Sitapur district. District Magistrate (Bahraich) Monika Rani said this was the eighth death in wolf attacks since July 17. Seven children were among those killed and about 30 injured. In the sec ond incident, 70-year-old Kamala Devi from Mauja Kotiya village in the Barabigha area was injured when a wolf entered her house and attacked her early on Monday, they said. In the third incident, Suman Devi (45) was found injured in a suspected wolf attack early Monday and hospitalised the officials said.

July. Officials said that four of the six have been captured, but two remain at large, continu-

ing to pose a threat in the area. The Forest department is actively searching for these wolves using both thermal and regular drones, an offi-

cial informed.

Kolkata, Sept 2: The CBI Monday arrested the former principal of RG Kar Medical College and Hospital Dr Sandip Ghosh in connection with the alleged financial misconduct at the establishment, officials said.

Ghosh was questioned for the 15th day at the agency's Salt Lake office over the alleged rape and murder of the RG Kar hospital post-graduate trainee August 9.

He was later escorted to the CBI's Nizam Palace office in Kolkata which houses the agency's anti-corruption wing and was shown as arrested.

This is the second arrest in the ghastly RG Kar crime fallout scenario that took place 24 days after the crime was committed.

Earlier, a Kolkata Police civic volunteer, Sanjoy Roy, was arrested by the Kolkata Police and handed over to the central agency in connection with the medic's alleged rape and murder.

The Calcutta High Court ordered the transfer of the probe into the alleged financial irregularities at RG Kar hospital August 23 from a state-constituted Special Investigation Team (SIT) to the Central Bureau of

Investigation (CBI). The direction came in response to a petition by former deputy superintendent of the facility, Dr Akhtar Ali, who prayed for a probe hy the Enforcement Directorate (ED) into multiple counts of alleged financial misconduct at the state-run institute during the

tenure of its former principal. Ghosh served as principal of RG Kar Medical College from February 2021 to September 2023. He was transferred from RG Kar in October that year but inexplicably returned to that position within a month. He held his position at the hospital till the day the hospital doctor was found murdered.



**Landslide claims two** 

Katra/Jammu, Sept 2: Two women pilgrims from Punjab and Uttar Pradesh died while a five-year-old girl was grievously injured in a landslide on the new track to the Vaishno Devi shrine in Jammu and Kashmir's Reasi district Monday, officials said.

Movement of pilgrims on the Himkoti track was halted fol-



lowing the landslide but the pilgrimage to the shrine atop Trikuta hills continued through the traditional Sanjhichatt route, they said.

Describing the incident as "unfortunate", Jammu and Kashmir Lieutenant Governor Manoj Sinha expressed grief over the loss of lives and sanctioned an ex gratia of Rs 5 lakh each to the bereaved families.

The deceased have been identified as Sapna (27) of Dhianpur village in Punjab's Gurdaspur, and Neha (23) of Kanpur in Uttar Pradesh, officials said.

In a condolence message, Sinha said, "Extremely pained to learn about the loss of precious lives of pilgrims due to the unfortunate incident of shooting stones on Shri Mata Vaishno Devi Shrine track today. My deepest condolences to bereaved families in this hour of grief.'

Officials said the landslide hit the route near Panchi, three kilometres ahead of Bhawan, around 2.15 pm. A portion of an overhead iron structure was also damaged, they said.

The pilgrims were heading for the shrine when they got trapped under the iron structure following the landslide, of-\_\_\_ ficials said.

## Delhi HC rejects plea to quash defamation case against Kejriwal

BIP leader accused Arvind Kejriwal and AAP *leaders* of defaming the BJP by claiming the party was responsible for deleting 3 million names from the Delhi electoral rolls

New Delhi, Sept 2: The Delhi High Court Monday refused to quash the proceedings against Chief Minister Arvind Kejriwal and other AAP leaders in a defamation case over their remarks about alleged deletion of the names of 30 lakh voters belonging to some communities from electoral rolls here, saying the imputations prima facie lowered down the reputation of BJP.

The high court said the imputations were prima facie 'defamatory" with an intention of vilifying the Bharatiya Janata Party (BJP) and gaining undue political mileage. Justice Anoop

Mendiratta dismissed the plea by Kejriwal and three others - Aam Aadmi Party (AAP) former Rajya Sabha member Sushil Kumar Gupta, Minister of Education Atishi and party leader Manoj Kumar -- challenging the defamation proceedings pending before the trial court. The high court, which had

February 28, 2020 stayed the proceedings, vacated the interim order and asked the parties to appear before the trial court October 3. The AAP leaders had chal-

lenged a sessions court order which upheld a magisterial court's decision to summon them as accused in the complaint filed by BJP leader Rajeev Babbar.

The high court said a political party cannot be allowed to engage in mud-slinging and making



allowed to engage in mud-slinging and making 'mischievous, false and defamatory' imputations against rival political parties

"mischievous, false and defamatory" imputations against rival political parties.

"Under the constitutional schemes, the citizens have a right to know truthful and correct information in order to form an appropriate opinion about the social processes. However, at the same time, a political party cannot be permitted to sponsor the print media for political purposes, thereby slinging mud and making mischievous, false and defamatory imputations on the rival political parties," the high court said.

It further said, "The imputations in the present case are prima facie defamatory with an intention of vilifying BJP and

gaining undue political mileage by attributing that BJP was responsible for deletion of names of about 30 lakh voters belong-

ing to particular communities. The court said prima facie the tweets and press conferences appear to be malicious and defamatory to the BJP and specifically to its Delhi unit and the office bearers of the party, with serious consequences for having targeted particular communities.

The court said it is of the considered opinion that there is a fine distinction between legitimate criticism of the policies of a political party or the government or an organisation and intentional malicious imputations which

may be defamatory "The issue highlighted by the petitioners regarding discrepancies in the list of voters prepared and uploaded on the website of Election Commission may have been crucial and critical from the perspective of citizens, but imputing that the exercise of deletion of names of certain communities was at instance of BJP clearly exhibits that the imputations were made

### ABINET APPROVES DIGITAL AGRICULTURE MISSION

New Delhi, Sept 2: The Union Cabinet Monday approved an outlay of Rs 2,817 crore to support digital initiatives in the agriculture sector, aimed at enhancing farmers' income and providing direct-indirect employment opportunities in the

"The Union Cabinet, chaired by Prime Minister Narendra Modi, approved the Digital Agriculture Mission today with an outlay of Rs 2,817 crore, including the central share of Rs 1,940 crore," according to an official statement.

This scheme is one of the seven programmes approved by the Cabinet with an outlay of nearly Rs 14,000 crore.

The Digital Agriculture Mission is "conceived as an umbrella scheme to support digital agriculture initiatives, such as creating digital public infra-

structure, implementing the Digital General Crop Estimation Survey (DGCES), and taking up other IT initiatives by the central government, state governments, and academic and research institutions"

The aim is to make timely and reliable information available for the agriculture sector and provide farmer-centric digital service. Digital identity to farmers, similar to Aadhaar, is one of the key components of these digital initiatives.

To bring about a digital revolution in the farm sector, the government announced the building of Digital Public Infrastructure for agriculture in the Union Budget 2023-24. Further, in the Budget 2024-25, the augmentation of the DPI initiative for the agricultural sector has also been announced.

The Digital Public Infrastructure (DPI) for agriculture aims to provide com-



prehensive and useful data on farmers comprising authenticated demographic details, land holdings and crops sown," the statement said, adding this will include cultivators and tenant farmers, as per the policy of the state government.

It would also connect to relevant DPI of the state governments and central ministries to use data of farmers on livestock, fisheries, soil health, other vocations, family details and schemes and benefits availed, leading to innovative farmer-centric digital services in the sector.

"Aligned with the vision of Viksit Bharat@2047, the DPI for agriculture forms the core of the Digital Agriculture Mission," the government said.

The three DPIs to be built under the mission are Agristack, Krishi Decision Support System, and Soil Profile Mapping.

"Besides enabling farmer-centric digital services, these DPIs will make timely and reliable information available for the agriculture sector.

Out of these three DPIs, the AgriStack is a farmer-centric DPI that will enable efficient, easier, and faster services and scheme delivery to farmers. It is being built in a federated structure as a collaborative project between various agencies of the Centre and States.


It consists of three foundational registries or databases in the agriculture sector, which are - Farmers' Registry, Geo-referenced village maps and the Crop Sown Registry, created and maintained by the State Governments/Union Territories.

"Under AgriStack, farmers will be given a digital identity (Farmer ID) similar to Aadhaar, which will be a trusted 'Kisan ki Pehchaan'," the statement said. This 'Farmer ID' will be linked

dynamically to the State's land records, livestock ownership, crops sown, demographic details, family details, schemes and benefits availed etc.

Crops sown by farmers will be recorded through mobile-based ground surveys i.e. Digital Crop Survey to be conducted in each

Memorandum Understanding (MoU) is being signed between the centre and state governments to create and implement the DPI for agriculture. So far, 19 states have signed — MoUs with the Union Agriculture Ministry.





### **Bangladesh Parl** Speaker resigns

Dhaka: Bangladesh Parliament Speaker Shirin Sharmin Chaudhury resigned Monday, nearly four weeks after President Mohammad Shahabuddin dissolved the house following the ouster of Prime Minister Sheikh Hasina. Bangabhaban presidential palace officials said Chaudhury tendered her resignation to the President. Her resignation comes as she was accused in a murder case over the death of a jewellery worker during the anti-government protests. The case against Chaudhury is one of scores of others against ministers of the former cabinet and Awami League leaders.

### Pakistan roadside bomb kills three

Peshawar: A roadside bomb struck a bus in northern Pakistan Monday, killing three people including two security officials, police said, Another passenger was injured in the attack in Kohistan, a district in Khyber Pakhtunkhwa province, according to local police chief Abdul Rahim. The bus was heading to Dasu district, where Pakistan's biggest hydropower project is being built with Chinese help. No group claimed responsibility, but suspicion was likely to fall on the Pakistani Taliban, who have stepped up attacks on security forces in recent years.

### **SK President skips** Parl formal opening

Seoul: President Yoon Suk Yeol boycotted the formal opening of South Korea's Parliament Monday as his squabbles with the Opposition deepen over allegations of wrongdoing by top officials and his wife. It's a tradition for South Korean Presidents to deliver a speech at opening ceremonies for National Assembly sessions, and Yoon is the first to skip the event since the country's transition from a military dictatorship to democracy in the late 1980s.



## Israelis continue protests US researchers find Russia's launch site

Jerusalem, Sept 2: Israeli protesters took to the streets for a second day Monday and the largest trade union launched a general strike to press the government to reach a deal to return hostages still held by Hamas, after six more captives were found dead in Gaza.

The strike disrupted transport and medical services in several Israeli districts and many shops and businesses were closed after the head of the Histadrut union, which represents hundreds of thousands of workers, called for a general stoppage.

The recovery of the six hostages, who were shot dead between 48-72 hours before being found by Israeli forces, according to the health ministry, triggered a wave of grief and fury in Israel, prompting at least half a million people to take to the streets in Jerusalem and Tel Aviv Sunday.

The demonstrators are demanding Prime Minister Benjamin Netanyahu reach a ceasefire agreement with Palestinian militant group Hamas to bring the remaining hostages home.

### **UK cuts arms export** licences to Israel

LONDON: Britain will immediately suspend 30 of its 350 arms export licences with Israel because there was a risk such equipment might be used to commit serious violations of international humanitarian law, foreign minister David Lammy said Monday. Lammy said the decision to suspend the licences did not amount to a blanket ban or an arms embargo, but only involved those that could be used in the ongoing conflict between Israel and Hamas in the Palestinian enclave of Gaza. "We recognise, of course, Israel's need to defend itself against security threats, but we are deeply worried by the methods that Israel's employed, and by reports of civilian casualties and the destruction of civilian infrastructure particularly," Lammy told Parliament.

"We live in a country of law and respect the court's decision. therefore I instruct everyone to return to work at 2:30 pm, Histadrut chairman Arnon Bar-David said, a day after he described the strike as "a cry for the return of the hostages.

## new missile's potential deploy-



Washington, Sept 2: Two US researchers say they have identified the probable deployment site in Russia of the 9M370 Burevestnik, a new nuclear-powered, nuclear-armed cruise missile touted by President Vladimir Putin as "invincible."

Putin has said the weapon, dubbed the SSC-X-9 Skyfall by NATO, has an almost unlimited range and can evade US missile defenses. But some Western experts dispute his claims and the Burevestnik's strategic value, saying it will not add capabilities that Moscow does not already have and risks a radiation-spewing mishap.

Using images taken July 26 by Planet Labs, a commercial satellite firm, the two researchers identified a construction project abutting a nuclear warhead storage facility known by two names, Vologda-20 and Chebsara, as the

ment site. The facility is 475 km north of Moscow.

Reuters is the first to report this development.

Decker Eveleth, an analyst with the CNA research and analysis organization, found the satellite imagery and identified what he assessed are nine horizontal launch pads under construction. They are located in three groups inside high berms to shield them from attack or to prevent an accidental blast in one from detonating missiles in the others, he said.

The berms are linked by roads to what Eveleth concluded are likely buildings where the missiles and their components would be serviced, and to the existing complex of five nuclear warhead storage bunkers.

The site is "for a large, fixed missile system and the only large, fixed missile system that they're (Russia) currently developing is the Skyfall," said Eveleth. Russia's defense ministry and Washington embassy did not respond to a request to comment on his assessment, Burevestnik's strategic value, its test record and the risks it poses.

Meanwhile, Russian President Vladimir Putin arrived Monday in Mongolia, a member of the international court that issued an arrest warrant for him.

### **Brazil SC votes to uphold X suspension**

It is not possible for a company to operate in the territory of a country and intend to impose its vision on which rules should be valid or applied. Justice Dino said as he sided with Moraes.

### ISIS no longer a threat, says Iraq PM

Baghdad: Iraqi Prime Minister Mohammed Shia al-Sudani said that the Islamic State (ISIS) terrorist group no longer poses a threat to Iraq and dialogue to end the US-led international coalition to fight the IS group



continues. Al-Sudani made the remarks during talks with Major General Kevin C. Leahy, commander of the US-led coalition against ISIS in Iraq, in the presence of US ambassador to Iraq Alina L. Romanowski, said al-Sudani's media office in a statement, Xinhua news agency reported. The remnants of ISIS terrorists have turned into gangs that are being hunted by Iraqi forces in remote areas of the country, the statement said. The meeting focused on "the progress of the technical dialogue between Iraq and the US-led international coalition about ending the coalition's mission in the country and transferring the mission to bilateral relations between Iraq and the coalition member states," it said.

### Khan's military trial 'possible': **Defence minister**

Islamabad, Sept 2: Pakistan's Defence Minister Khawaja Asif has said that a military trial of jailed former Prime Minister Imran Khan was "possible" in the cases concerning the violence May 9 last year.

"Yes, it is possible," Asif replied when asked during the Geo News programme 'Naya Pakistan' Sunday if a military trial of the former premier was possible.

He said that during the Imran Khan-led government, military trials of the civilians were held and he "remembers cases of 24 civilians" who went through the process of facing military court.

It is not the first time that the ruling Pakistan Muslim League-Nawaz (PML-N) expressed such a possibility. Several leaders of the party have accused Khan of orchestrating the May 9, 2023 violence. On May 9 last year, violent protests erupted after the arrest of 71-year-old Pakistan Tehreek-e-Insaf (PTI) party founder Khan by paramilitary Rangers from the premises of the Islamabad High Court in connection with an alleged cor-

ruption case. His party workers allegedly vandalised a dozen military installations, including the Jinnah Corps House (Lahore Commander House), the Mianwali airbase and the ISI building in Faisalabad. A mob also attacked the Army headquarters in Rawalpindi.

## B'desh to restart dialogue with India

Dhaka, Sept 2: Bangladesh's interim government wants to restart with India the dialogue on the Teesta water sharing treaty, adviser on water resources Syeda Rizwana Hasan has said, asserting that upper-riparian and lower-riparian countries should adhere to international principles on the distribution of water.

Speaking to PTI in Dhaka, Hasan expressed confidence that the Teesta treaty and other watersharing agreements with India would be resolved amicably through dialogue but suggested that Bangladesh might consider international legal documents and principles if an agreement cannot be reached.

"I have discussed the issue of Teesta water sharing with all relevant stakeholders (in Bangladesh). We have discussed that we need to restart the process and dialogue regarding the Teesta treaty. We also have to work on the Ganges treaty, which is coming to an end in two years," she told PTI in an interview

"Both sides agreed, and a draft of the Teesta water-sharing agreement was prepared, but the agreement was not signed due to the opposition of the West Bengal Chief Minister. The fact remains that we have not been able to finalise the agreement. So, we will start from that point with the draft of the agreement and urge India to come forward



India and Bangladesh were set ing during then-Prime Minister Manmohan Singh's Dhaka visit in 2011, but West Bengal Chief Minister Mamata Banerjee declined to endorse it, citing scarcity of water in her state. "We would try to find an am-

icable solution. As this is an international water issue, it also concerns other countries' consideration of legal entitlement. So, how much water is available and whether it is sufficient is unclear to us. Even if very minimal water is available, the flow must continue to Bangladesh due to international sharing norms," she said.

Hasan noted that the issue of international water sharing can be better handled if both upperriparian and lower-riparian countries adhere to certain international legal principles.

"Bangladesh may consider endorsing international legal principles and documents regarding water sharing. That is what I mean when I say we might engage internationally," the renowned environmentalist of Bangladesh said.

The 56-year-old adviser to Bangladesh's Department of Water, Forest, Environment, and Climate Change said the interim government has not yet discussed taking the issue of water sharing with India to the international forum.

"I don't think we have discussed that yet. I think the first step for Bangladesh will be to address it with India and Nepal. We haven't discussed taking this matter to any other country at this stage," she said, asserting that the "issue can be resolved amicably with India."

When asked about the erstwhile Awami League regime's failure to seal the Teesta deal with India, Hasan said, "It did not work all these years because of the political context that Bangladesh had.

## Turkey bids to join BRICS in push to build alliances beyond West

urkey has formally asked to join the BRICS group of emerging-market nations as it seeks to bolster its global influence and forge new ties beyond its traditional Western allies, according to people familiar with the matter.

The view of President Recep Tayyip Erdogan's administration is that the geopolitical center of gravity is shifting away from developed economies, according to the people, who spoke on condition of anonymity because they aren't authorized to comment.

The country's new diplomatic push reflects its aspirations to cultivate ties with all sides in a multipolar world, while still fulfilling its obligations as a key member of the North Atlantic Treaty Organization, they said.

Straddling Europe and Asia, Turkey submitted an application to join BRICS some months ago amid frustration over a lack of progress in its decades-old bid to join the European Union, the people added. The bid is also partly a result of rifts with fellow NATO members after Turkey maintained close links with Russia following its invasion of Ukraine in 2022, the people added. Turkey's foreign ministry and presidency declined to comment.

"Turkey can become a strong, prosperous, prestigious and effective country if it improves its relations with the East and the West simultaneously," Erdogan said in Istanbul over the weekend. "Any method other than this will not benefit Turkey, but will harm it.'

The BRICS grouping, named after Brazil, Russia, India and China and South Africa, includes some of the biggest emerging economies. It got four new members at the start of this year



when Iran, the United Arab Emirates, Ethiopia and Egypt joined its ranks. Saudi Arabia was invited to join, though the kingdom is yet to do that.

The group's further enlargement could be discussed during a summit in Kazan, Russia, from October 22-24, said the people. Malaysia, Thailand and Turkey's close ally Azerbaijan are among other countries looking to join.

The BRICS touts itself as an alternative to what its members see as Western-dominated institutions such as the World Bank and International Monetary Fund. New members

can potentially get access to financing through its development bank as well as broaden their political and trading rela-

tionships. Erdogan's ruling Justice and Development Party has long accused Western nations of thwarting Turkish aspirations for a self-sufficient defense industry and strong economy. The President has repeatedly called for an overhaul of the United Nations Security Council to broaden its five permanent members, and expressed interest in joining the Shanghai Cooperation Organization, set up by Russia and China as a rival to NATO.

BRICS expansion has largely been driven by China, which is trying to boost its global clout by courting nations traditionally allied with the US.

Turkey has been in talks to join the EU since 2005, but has encountered a series of obstacles, including what that bloc describes as the country's democratic shortcomings.

Turkey believes joining the BRICS could help the country improve economic cooperation with Russia and China, and become a trade conduit between the EU and Asia. It wants to be a hub for gas exports out of Russia and Central Asia, the people said.


New Delhi, Sept 2: The government Monday cleared a proposal of Kaynes Semicon to set up a ₹3,307-crore semiconductor unit in Sanand, Gujarat, that will have the capacity to churn out 6.3 million chips a

Addressing reporters after the Union Cabinet meeting, IT Minister Ashwini Vaishnaw noted that a complete semiconductor ecosystem is coming up in India under the India Semiconductor Mission, and promised that the country will take a long-term view of this "foundational" sector and increase the outlay, as needed.

He likened the semiconductor industry to steel and chemicals industries which feed into many other allied sectors, and said the sector will be "crucial" for India's growth and the industrial production blueprint of the country.

The minister said that the progress of Tata's fab, a complex project, has been "very good", and added that land has been allocated, and geo-technical investigations are done.

"Today, the Cabinet has approved Kaynes' plant, with a capacity of 6.3 million chips per day. The plant will come up in 46 acres, it is a big plant and large portion of the production will go for Kaynes Industries, it has already been booked," the minis-

Chips produced in this unit will cater to a wide variety of applications which include segments such as industrial, automobile, electric vehicles, consumer electronics, telecom, and mobile phones amongst others.

"Power-related chips..chips used in automobiles and home appliances, will also be produced in this plant," Vaishnaw said briefing reporters.

Giving an update on Tata's Dholera plant, the minister informed that land acquisition has already been done for the "massively large and complex project".

It is pertinent to mention here that Tata Electronics will set up a semiconductor fab in partnership with Powerchip Semiconductor Manufacturing Corp (PSMC) of Taiwan. This fab will come up at Dholera in Gujarat, and entail an investment of ₹91,000 crore

Known for its expertise in logic and memory foundry segments, PSMC has six semiconductor foundries in Taiwan.

On the status of Micron's project, the minister said that the first Made in India chip will come up in the middle of next

In June last year, Micron announced an investment of \$825 million to set up a new assembly and test facility in Guiarat.

Kaynes said the employability from Kavnes' and other semi conductor-related projects in India needs to be seen in the context of a multiplier impact that semiconductor has as a foundational industry.

"When we look at employment generation potential of semiconductor plant, we have to think like a steel plant, chemical, plastic plant or refinery...as foundational industry that feeds into many industries," he said

### JSW Cement's ₹4K-cr IPO in 'abeyance'

New Delhi, Sept 2: Capital markets regulator Sebi has put on hold the proposed ₹4,000-crore initial public offering (IPO) of JSW Cement.

Without specifying reasons, Sebi stated that the "issuance of observations (has been) kept in abeyance," according to an update on its website Monday. JSW Cement, part of the di-

versified JSW Group, filed the preliminary IPO papers with Sebi August 16.

The proposed issue involves a new issue of equity shares worth ₹2,000 crore and an offer-for-sale (OFS) of ₹2,000 crore by investor shareholders, according to the draft red herring prospectus (DRHP) filed with the regulator.

Under the OFS, AP Asia Opportunistic Holdings Pte Ltd and Synergy Metals Investments Holding Ltd will offload shares worth ₹937.5 crore each and State Bank of India (SBI) will divest shares valued at ₹125 crore.

Proceeds from the fresh issue to the tune of ₹800 crore will be used for partially financing the establishment of a new integrated cement unit in Nagaur, Rajasthan, while ₹720 crore will be allocated for payment of debt and the remaining funds will be allocated for general corporate purposes

JSW Cement, which has a manufacturing capacity of 19 MT annually, aims to achieve the capacity of 60 MTPA. It currently has manufacturing units at Vijayanagar in Karnataka, Nandyal in Andhra Pradesh, Salboni in West Bengal, Jajpur in Odisha and Dolvi in Maharashtra

Besides, JSW Cement through its subsidiary Shiva Cement operates a clinker unit in Odisha.

JM Financial Ltd, Axis Capital Ltd, Citigroup Global Markets India Private Ltd, DAM Capital Advisors Ltd. Goldman Sachs (India) Securities Private Ltd, Jefferies India Private Ltd, Kotak Mahindra Capital Company Ltd and SBI Capital Markets Ltd are responsible for managing the company's IPO process.

New Delhi, Sept 2: A study by markets regulator Sebi high lighted flipping behaviour among investors in the initial sharesale market with investors (excluding anchor) selling 54 per cent of IPO shares allotted to them by value within a week.

The study found a strong disposition effect (tendency to prematurely sell assets that have made financial gains) with investors showing a greater propensity to sell IPO shares that posted positive listing gains, compared to those that listed at a loss. In light of the increasing par-

ticipation of retail investors and the heightened oversubscription in recent IPOs, the Securities and Exchange Board of India (Sebi) conducted an in-depth study to analyze investor behaviour in main-board IPOs. The study encompasses data from 144 IPOs listed between April 2021 and December 2023.

During the study period, 144 IPOs collectively raised a total of ₹2.13 lakh crore. Notably, 65 per

According to the study, "About 54 per cent of IPO shares (in value terms) allotted to investors (excluding anchor investors) were sold within a week from listing".

Individual investors sold 50.2

per cent shares (in value terms) allotted to them within a week from listing, non-institutional investors (NIIs) offloaded 63.3 per cent shares and retail investors sold 42.7 per cent shares.

The index surged for the 10th straight session, which is its longest gaining streak since September 2023 when it rose for nine straight days in the first half of the month. The NSE Nifty rose for the 13th straight day, which experts said, was its

longest winning run in decades. The 50-share index climbed 42.80 points or 0.17 per cent to settle at a lifetime high of 25,278.70. During the day, it soared 97.75 points or 0.38 per cent to hit a

fresh intra-day peak of 25,333.65. In a 13-day gaining streak

since August 14, the Nifty has rallied 4.72 per cent or nearly 1,140 points. Sensex has risen by 2.65 per cent or 2,135.16 points in its 10 straight days of gains.

Expectations of an interest rate cut by the US Federal Reserve this month and renewed foreign fund inflows have fuelled the recent rally in domestic equities, traders said.

Among the 30 Sensex firms, Bajaj Finserv, Bajaj Finance, HCL Tech. IndusInd Bank, ITC, UltraTech Cement, Axis Bank and Infosys were the biggest gainers.

On the other hand, Tata Motors, NTPC, Mahindra & Mahindra, Bharti Airtel, Larsen & Toubro and Power Grid were among the laggards.

podium in Paris Monday. Antil recorded a highest throw of 70.59m in his second attempt. which remained the highest throughout the competition.

Antil delivered an impres-

sive performance in the final, launching a throw of 69.11m on his first attempt and then surpassing it with a new Paralympic record in the F64 category by breaking the 70m barrier. He continued his strong form with a third throw of 66.66m.

Despite a foul on his fourth attempt, Antil wrapped up the event with solid throws of 69.04m and 66.57m in his fifth and sixth attempts, respectively. No other competitor managed to cross the 70m mark.

Sri Lanka's Kodithuwakku secured the silver medal with a top throw of 67.03m, while Michal Burian claimed bronze with a best of The 26-year-old world record

holder from Sonipat, Haryana, surpassed his previous Paralympic record of 68.55m, which he set while winning gold in Tokyo three years ago.

Antil's world record remains an impressive 73.29m.

He becomes only the second Indian athlete, following shooter Avani Lekhara, to successfully defend a Paralympics title.

The F64 category is designated for athletes with lower limb impairments, including those who compete with prosthetics or have differences in leg length.

### Dhanush sinks records as India make clean sweep

New Delhi, Sept 2: The Indian trio of Dhanush Srikanth, Shourya Saini and Mohammed Murtaza Vania made a clean sweep of the 10m Air Rifle men's event on Day Two of the 2nd World Deaf Shooting Championship 2024 being held at Hanover, Germany.

Mahit Sandhu and Natasha Joshi also won silver and bronze in the women's event as India added five medals to the four (one gold, two silver and one bronze) they won on Day One of the competition.

Dhanush shot a double deafshooting world record in a single day, with a 632.7 to top the qualification round and then a 251.7 in the final to leave his compatriot Sourya (249.9) well be-

hind in second. Mohammed Murtaza had earlier bowed out with a bronze having shot 226.2

India has selected a 16-member squad for the 2nd World Deaf Shooting Championship 2024. The Indians made a bright start by winning one gold, two silver and one bronze medal on Day One of competition.

Anuya Prasad won gold in the women's 10m Air Pistol. In comparison. India also had a double podium finish in the men's 10m Air Pistol with Abhinav Deshwal claiming silver and Shubham Vashist bagging bronze as the duo also teamed up with Chetan Sakpal to clinch the team silver in the Championship, which will go on till September 7. The Indian shooters will compete in the Air Rifle and Air Pistol disciplines.

## Tiafoe topples Popyrin, Zverev in QFs

New York, Sept 2: The 20th seed Francis Tiafoe registered a 6-4, 7-6(3), 2-6, 6-3 win to fend off giant-slayer Alexei Popyrin and reach the US Open quarterfinals for a third consecutive year.

Popyrin scribed his name in US Open lore when he sent defending champion Novak Djokovic tumbling out of the draw just 48 hours prior to

Sunday's fourth-round contest. With the win, Tiafoe continues to make history for American men's tennis, becoming the fourth American man to appear in three US Open quarterfinals since 2000. The feat puts him in elite company with Andre Agassi, Andy Roddick and Pete Sampras as the only other men to do so this

Tiafoe looks to keep his momentum going in the quarterfinals against No 9 seed Grigor Dimitrov, who eliminated sixth seed Andrey Rublev earlier in the day. The Bulgarian holds a 3-1 edge over Tiafoe in head-to-head

In other action, Alexander Zverev of Germany ended American Brandon Nakashima's run to reach the quarterfinals in New York for the fourth time.

Zverev recovered from scratchy play in the first set and won 29 first-serve points in a row to end Nakashima's dream run, defeating the American, 3-6, 6-1, 6-2, 6-2 in two-hour, 38-minute and notched his 450th win.

Zverev will next face Taylor Fritz in a rematch of their fourth-

### **Bopanna-Ebden ousted**

ndia's challenge in the men's doubles event of the US Open ended with the defeat of Rohan Bopanna and his Australian partner Matthew Ebden in the third round, here. The second seeded Bopanna-Ebden pair lost 1-6 5-7 to the 16th seed Argentine combo of Maximo



Gonzalez and Andres Molteni in 66 minutes Sunday night. Bopanna and Ebden had won the Australian Open early this year. The 44-year-old Bopanna has already announced retirement from Davis Cup and it will be interesting to see if he will return to defend his Australian Open crown in January 2025. Sumit Nagal had exited the men's singles with an opening round defeat while Yuki Bhambri and N Sriram Balaji earlier lost in men's doubles at different stages of the tournament. Bopanna's challenge is still alive in the mixed doubles event with Indonesian partner Aldila Sutjiadi and interestingly, he and Ebden will now be up against each other.

### **Navarro dethrones Gauff**

mma Navarro advanced to her first US Open quarterfinal after the 23-year-old American defeated Gauff in a straightsets, fourth-round match. After a convincing upset of Gauff earlier at Wimbledon, this was the second time in a row at a major, that Navarro beat her countrywoman. The No 13-seeded Navarro



backed up that breakthrough with a 6-3, 4-6, 6-3 win to advance to her second straight major quarterfinal. That ended No 3 Gauff's title defense and a muscular 11-match winning streak in New York.

On the other hand, No 1 American Fritz fired past 2022 US Open runner-up Casper Ruud of Norway 3-6, 6-4, 6-3, 6-2 to reach the quarterfinals in New York
