factory mishap

Jharsuguda: Two contractual workers were crushed to death, and five more sustained critical injuries, after a metal filter plate fell on them at the Orissa Metaliks Private Limited (OMPL) factory at Budhipadar in the district, Tuesday. The deceased were identified as Purnachandra Jena, 40, and Alekh Deo Sahu, 35. The mishap occurred at around 11 am when the metal filter plate in the blast furnace unit came off and fell on the workers, trapping them underneath. The injured labourers were rescued and rushed to a private hospital where doctors pronounced Jena and Deo dead. The five injured labourers have been admitted to the intensive care unit of the hospital.

PM launches Subhadra

Modi also unveils railway, national highway projects worth over ₹3,800 crore

Bhubaneswar, Sept 17: Prime Minister Narendra Modi Tuesday launched Odisha government's flagship women empowerment programme, 'Subhadra Yojana', besides unveiling railway and national highway projects worth over ₹3,800 crore, marking 100 days of the NDA government 3.0.

Besides, he released the first instalment of assistance to nearly 10 lakh beneficiaries under PMAY-G across 14 states, took part in 'Griha Prayesh' celebrations for 26 lakh beneficiaries under the housing scheme, and launched Awaas+ 2024 App for a survey of additional households for the same programme.

PM Modi's visit to the state on his 74th birthday would be the first after he attended the swearing-in ceremony of Chief Minister Mohan Charan Majhi June 12.

"I am happy that the Odisha government started its major work by announcing Subhadra Yojana for women. Women's empowerment will be the key to Odisha's development," he said while addressing a massive gathering at the Janata Maidan here.

The PM noted that Odisha has everything that is required for



a developed state. "It has a talent pool of youth, the strength of women, natural resources, opportunities for industries, immense possibilities of tourism," Modi said.

While participating in the Griha Pravesh celebrations, Modi visited Sabar Sahi slum in

Bhubaneswar where he interacted with the beneficiaries. The PM inaugurated the homes of 20 beneficiaries under

the PMAY there. Accompanied by the chief minister, Modi visited the home of Antaryami Nayak, a beneficiary of the housing scheme, and savoured the traditional Odia sweet dish, 'kheeri, prepared at his residence. Sharing his experience after he was offered 'kheeri' by a tribal family on the occasion of his birthday

in Bhubaneswar, Modi said, "When my mother was alive, I used to visit here and seek her blessing on my birthday. She used to give me jaggery. Today, I got the blessings of a tribal mother who offered me 'kheeri'. The happiness of tribals gives me strength to work for them."

The Odisha government's Subhadra Yojana, billed as the largest programme for women. will cover more than 1 crore beneficiaries.

Under the scheme, ₹10,000 will be provided to each beneficiary every year in two equal instalments for a period of five

After the launch, the prime minister initiated the fund transfer into the bank accounts of more than 10 lakh women. He said that the promises made by the BJP during the elections were being fulfilled at a rapid pace.

Listing the promises fulfilled so far, he said all the four gates of the Jagannath temple in Puri were thrown open to the public and the 12th-century shrine's Ratna Bhandar (treasury) was also reopened in July after 46 years for making an inventory of valuables and repairing of its structure.

Apex court halts 'bulldozer justice'

New Delhi, Sept 17: Even if there is one instance of illegal demolition, it is against the ethos of our Constitution, the Supreme Court said Tuesday while directing that authorities across the country will not demolish properties, including of those accused of crime, till October 1 without seeking its permission.

A bench of Justices BR Gavai and KV Viswanathan clarified that its order will not be applicable to unauthorised structures on public roads, footpaths etc. "Even if there is one instance of

an illegal demolition, it is against the ethos of our Constitution," the bench observed. It said till October 1, the next date of hearing, no demolition be carried out "without seeking leave of this court". The top court was hearing pe-

titions alleging properties of those accused of crime were being demolished in several states illegally. Solicitor General Tushar Mehta told the bench that a "narrative" was being built over the demolition of properties.

He said there was a petition before the apex court which alleged that because the person belonged to a particular religion, his property was demolished. "Let them bring to your lordships" notice one instance of demolition where the law is not complied (with)," the law officer said. P9

DGP orders CB probe

Bhubaneswar, Sept 17: Two days after Orissa POST and Dharitri launched a campaign for justice to a serving Indian Army officer and his female friend who were allegedly assaulted and misbehaved by Bharatpur police who they approached to report a road rage instance in the wee hours of Sunday a Crime Branch (CB) team Tuesday grilled officials at the police station following a direction from Director General of Police (DGP) YB Khurania for a detailed probe into the alleged incident of police highhandedness.

According to reports, ADGP, CB-CID, Arun Bothra deputed a five-member team, led by DSP Narendra Behera, to look into the allegations. The investigating agency has also directed the police station to withdraw the complaint lodged against Ankita Pradhan—the friend of Major Gurvansh Singh, attached to 22 Sikh Regiment in Kolkata.

The team, which visited the police station in early hours of Tuesday, held a marathon questioning of the police officials for over four hours, during which those concerned with the investigation were asked to produce records related to the case.

"We have asked Bharatpur IIC Dinakrushna Mishra to furnish a detailed explanation in this regard. Another team will visit Jharpada Special Jail to record Ankita's statement before submitting a detailed report," said a member of the team.

Meanwhile, slamming the police excess, the Central Command of Indian Army Monday took to X to say, "An incident of manhandling of an Army officer by police sta-

Atishi stakes claim to form new Delhi govt

New Delhi, Sept 17: Delhi Chief Minister Arvind Kejriwal tendered his resignation to Lieutenant Governor V K Saxena here Tuesday and AAP leader Atishi, chosen by the party as his successor, staked her claim to form a new government.

Kejriwal reached the LG Secretariat along with his Cabinet colleagues to resign Tuesday afternoon, days after announcing his decision to quit from the post. Addressing reporters after the

meeting, Atishi said, "We have staked claim to form a new government. I will protect the interests of Delhi people."

Delhi minister Gopal Rai said, "We have informed the LG about his decision. Atishi has presented her claim to form the government. We have requested the LG to decide on a date for the oath-taking ceremony so that the work of two crore people can be carried on."

The chief minister-designate alleged that Kejriwal was facing false charges and being targeted by the Central government's probe agencies.

"The Supreme Court not only granted bail him but also made harsh remarks against the Centre and its probe agencies calling them a caged parrot," she added.





Bhubaneswar, Sept 17: Prime Minister Narendra Modi dedicated to the nation and laid foundation stones of key railway projects valued at ₹2,871 crore in Odisha, Tuesday.

These projects are set to enhance rail connectivity, decongest key routes, and contribute to the socio-economic development of the region, the PM said.

Among the projects inaugurated was the 25km Lanjigarh Road-Ambadola-Doikallu railway section, part of the Vizianagaram-Titilagarh third line project costing ₹432 crore. This section will improve connectivity between western

facilitate smoother freight move-

Another project is the 23km

railway section, part of the Koraput-Singapur road doubling project which was completed at ₹260 crore. This section aims to increase train movement capacity in southern

Odisha and ease freight move-

ment from resource-rich areas

to major markets. Modi also dedicated the 41km Dhenkanal-Sadashibapur-Hindol Road railway section of the Budhapank-Salegaon third and fourth line project worth ₹540 crore. This project will augment capacity on a crucial industrial route, ensuring more efficient transportation of goods.

Additionally, the 12.5km Bangurkela-Nowgaon railway section of the Bondamunda-Ranchi doubling project, comnleted at ₹239 crore will reduce congestion and improve connectivity between Odisha and Jharkhand, they added.

In addition, Modi also laid foundation stones of four railway

These include a 7km flyover between Siju and Paradeep coaching yard costing ₹200 crore which will eliminate surface crossings and ensure smoother train movements at Paradeep Port.

The expansion of the Paradeep-Badabandha third and fourth line, spanning 19km and costing ₹300 crore, will boost capacity for both freight and passenger traffic, enhancing connectivity to Paradeep Port, officials said.

The doubling of the MCRL Inner Corridor Phase-1, which will cover 10.93km and cost ₹152 crore, is intended to facilitate smooth coal evacuation.

The highly anticipated 41.9km Jeypore-Nabarangpur New Line, costing ₹748 crore, will connect the tribal-dominated regions of Jeypore and Nabarangpur, fostering economic growth and improving access to markets and re-

"This aspirational project will link the tribal-dominated areas of Jeypore and Nabarangpur, providing improved access to markets and services for the region's people. The new line is expected to play a transformative role in the economic upliftment of the area, promoting employment, trade, and mobility," the East Coast Railways (ECoR) said in a statement.

Even at that time, the British who followed the policy of divide and rule used to hate Ganesh Utsav. Even today, the power-hungry people, who are busy dividing society are having problems with Ganesh Puja. You must have seen that the people of Congress and its ecosystem are angry because I participated in Ganesh Puja," Modi said at the rally.

He also said that Lord Ganesh was "put behind bars" in Congress-ruled Karnataka by these people.

Modi was apparently referring to a viral photo of Ganesh idol in a police van in the south-

POOR SPEND LOWERED SMART CITY RANKINGS

Bhubaneswar, Sept 17: The Bhubaneswar Smart City Limited (BSCL) and Rourkela Smart City Limited (RSCL) failed to achieve their targets as the special purpose vehicles (SPVs) spent only 36 per cent and 37 per cent of the allocated funds for the projects, respectively, approved as per their Smart City Plans (SCPs) till March 2022, resulting in the cities' poor performance in the smart city rankings, according to the Comptroller and Auditor General of India (CAG).

In its recently-released report, the auditor said BSCL took up projects worth ₹1,621.94 crore against the target of ₹4,537 crore with a 41 per cent reduction in the number of Area Based Development (ABD) projects. "There were plans for 56 ABD projects worth ₹4,096 crore in case of BSCL. However, it undertook only 33 projects worth ₹939.85 crore," the report said.

The RSCL, which was supposed to take up ₹2,571 crore projects, executed initiatives worth ₹950.46 crore. Although the number of planned ABD projects increased from 30 to 59 in case of RSCL, the corresponding investment was reduced 50 per cent – from ₹1,702.24

crore to ₹844.49 crore. In case of Pan City projects, the investment was reduced to ₹106.42 crore from the planned ₹869.03 crore although the number of projects remained constant at one, it said.

"In March 2023, the state government attributed the reduction in ABD projects to reasons like non-availability of fund and encroachment-free land. The reply was not acceptable as SPVs like BSCL and RSCL were responsible for mobilising funds and coordinating with other departments for related issues," the CAG said.

The auditor said the performance of the SPVs deprived the cities' dwellers of the envisaged benefits. "As a consequence, both the cities lost their rankings as smart city drastically as stated supra," it said.

The audit observed that ranking of smart cities are done through Geospatial Management Information System (GMIS), a management information system, developed by Ministry of Housing and Urban Affairs (MoHUA), on the basis of basic parameters like physical progress of work and various outcomes and impacts being generated by them. Due to less physical and financial progress in SCM projects, the smart city rankings of both the cities had reduced, from 1 to 48 and 45 to 65, respectively, for BSCL and RSCL, as of March 2022.

It is noteworthy that the dedicated LSFTO rakes will play a pivotal role in transporting RSP's high-quality steel from plant to customers, ensuring a streamlined and efficient supply chain connecting all rail terminals across Indian Railways, including SAIL terminals.

In the customised wagons, load adjustment can be planned better to reduce dead freight.

The number of dispatchable steel rakes will increase leading to additional sales turnover of the company.

The inbuilt lashing mechanism will reduce the loading, metal saddle and lashing cost substantially, while the use of wooden dunnage will be completely eliminated thereby reducing the carbon footprints, RSP sources said.

POOR SLEEP MAY W

hile a good night's sleep is known to be crucial for overall health, a new study showed it can also prevent cirrhosis among individuals with nonalcoholic fatty liver disease (NAFLD).

Cirrhosis occurs when the liver is damaged for over a long duration and is replaced by scar tissue. The scarring prevents the liver from working properly, and can eventually lead to liver failure

The study led by researchers from the Huazhong University of Science and Technology in China showed an association between a healthy sleep pattern and a decreased risk of cirrhosis among NAFLD patients.

The study on 112,196 NAFLD patients found that poor sleep patterns were associated with an increased risk of progression to cirrhosis. The benefits of good sleep were observed in participants, regardless of low or high genetic risk, according to the journal Hepatology International.

The study provides "more evidence that sleep is really un-



derrated," said Abby Phillips, popularly known as LiverDoc, on social media platform X.

'You can't change your genetic profile and neither can

evervone check their genetic profile. But what can be done is get some good sleep every night," he advised. The human body requires optimum sleep duration of 7-8 hours per night.

"Having a good night's sleep (at least 7-8 hours) has innumerable benefits on liver health and this is something not many are aware of," Phillips said.

Poor sleep is also known to be harmful to health and can lead to problems with memory and focus. It can also raise the risk of headaches, anxiety, and stress.

Another recent study, published in the journal Sleep shows that sleeping late may also raise the risk of early-onset type 2 diabetes.

In the study, people who went to bed after midnight had a 1.46fold increased risk of developing early-onset diabetes -- under the age of 40.

"Each one hour later in bed time was associated with a 52 per cent increase in the risk of early-onset diabetes," the study

SHAKEN IN SIX MONTHS

PANIC AS JODA FLYOVER SINKS

Joda, Sept 17: Barely six months after the inauguration of the flyover running through this town in Keonjhar district, a portion of it sank leaving the commuters panicked, according to a

While a crater has formed on the flyover, cracks have also appeared on the retaining walls of the bridge. The left portion of the approach road to the flyover has sunk leading to formation of a crater. The newly-inaugurated bridge developing such problems has raised questions about the durability of the crucial infrastructure.

On being informed, Collector Vishal Singh directed a technical team and Odisha Bridge Construction Corporation Ltd (OBCCL) engineer to inspect the damage and take necessary steps for its repair, Monday.

It's not just the cracks that are bothering the users. Earlier, concrete slabs were seen loosely hanging at various places while at other places iron rods were found protruding out putting the lives of the commuters at

risk. Someone can seriously get injured due to the rods, they

Reports said that the flyover was constructed at a plan outlay of ₹250 crore from the funds available from the district mineral foundation (DMF).

Sources said the 3-km long flyover was inaugurated by the former Chief Minister Naveen Patnaik on virtual mode March 11, 2024. Hence, the appearance of cracks in less than six months of its inauguration has created serious apprehensions amongst the commuters.

The bridge was built by Gujarat-based Chevrox Constructions Private Ltd which had then claimed that the bridge has been built using the latest technology.

Chevrox head Bipul Barat, its chairman Kishore Birangama, OBBC general manager Narsingh Mohanta who were present at the time of inauguration had claimed that the flyover will last more than 100 years. Mohanata had also claimed that it can endure the movements of heavy to very heavy vehicles. Now, it seems that the The flyover was built by **Gujarat-based Chevrox Constructions Private** Ltd which had claimed that the bridge has been built using the latest technology

tall claims have fallen flat.

Such is the condition of the flyover that it shakes violently when a couple of heavy vehicles pass over it simultaneously. Pictures of the shaking bridge have gone viral on social media

Locals had alleged that the previous state government inaugurated the flyover hastily without conducting proper examination of the bridge as Lok Sabha and Assembly elections were nearing.

They wanted to take credit for construction of the bridge but safety concerns have now cropped up.

This correspondent tried to meet Chevrox Constructions Private Ltd GM Sudip Mukherjee for his comment but he was conspicuously absent.

An engineer of OBCCL, requesting anonymity, confirmed the cracks on the retaining wall but ruled out any immediate threat to the commuters. The senior officials are aware of the issue and the damaged portion will be repaired soon, he said. He also informed that Keonjhar Collector has been apprised of the

Rourkela, Sept 17: The Karmaveer Quality Circle team from coke ovens department of SAIL's Rourkela Steel Plant has brought about substantial savings for the company apart from enhancing the safety and efficiency of operations in Battery-6.

Notably, Battery-6 houses 67 state-of-the-art 7-metre-tall ovens that make 0.9 million tonne coke annually

There was a critical concern in the CDCP unit of coke ovens, where mill-fan failures during the dry quenching process led to a halt in fuel gas circulation, risking coke combustion and potential explosions that could damage chamber lids and walls. The existing hydraulic system was insufficient for opening the cooling chamber lids under these conditions, posing serious operational

The QC team comprising Sanjay Kumar Sahoo, senior technician, Hadibandhu Sahoo, Aswini Kumar Behera, and Deepak Kumar Dey, operators, under the guidance of Kulamani Sahoo, technician and B Panda, senior manager, coke ovens addressed the issue and implemented a crucial modification in the hydraulic system by adding an additional accumulator.

This innovative solution not only enhanced operational safety but also maximised pushing in Battery-6 and cooling cycles in the CDCP unit, leading to a substantial saving of ₹2.7 crore annually. The enhancement ensured the exertion of sufficient hydraulic pressure, allowing for easier lid opening during millfan failures, thereby preventing coke burning and explosions. Meloni Model

Pritish Prime Minister Keir Starmer and his Italian counterpart, Giorgia Meloni, who heads the far-right anti-immigration Brothers of Italy party, met in Rome 16 September. This meeting has sparked off a controversy as the two leaders discussed the highly sensitive and thorny issue of tackling illegal immigration. His statement, before the meeting, that he wanted to understand the methods used which have brought about dramatic reduction in migrant arrival numbers in Italy has attracted criticism from members of his own left-leaning Labour Party. Starmer also visited a national immigration coordination centre with Italy's interior minister, Matteo Piantedosi.

Since Labour won elections in July, Starmer has promised to fight illegal immigration even while rejecting the previous Conservative government's plan to deport asylum seekers to Rwanda. Labour MP Kim Johnson told the media it was disturbing to see Starmer "seeking to learn lessons from a neo-fascist government" of Italy. It is noteworthy that the visit came shortly after the UK was rocked by far-right riots during which mosques and migrant accommodation centres were targeted.

Already, the arrival of undocumented migrants and asylum seekers in small boats from France remains a perilous issue for Britain's political parties. More than 22,000 people have made the dangerous crossing of the English Channel so far this year, a slight increase from the same period in 2023. Several dozen have perished, including eight killed when a boat carrying about 60 people ran aground on rocks late last week. The same day, 14 boats carrying 801 people reached Britain.

Home Secretary Yvette Cooper defended the government's decision to seek advice from Italy's right-wing administration with the argument that the government had "a moral imperative to make sure that we are pursuing the criminal gangs who are putting lives at risk.'

Interestingly, even though Starmer has rejected the Rwanda plan, he has not ruled out arrangements that would see asylum claims processed

Italy reached an agreement with Albania in November to host two centres where people would be housed while their asylum claims are processed. Those with rejected asylum claims would be sent back to their countries of origin whereas those with accepted applications will be granted entry into Italy.

Meloni's government has also inked a deal with Tunisia, granting it aid in exchange for greater efforts to stop Italy-bound refugees who leave the North African country to cross the Mediterranean. Rome has also renewed a deal with the Libyan government in Tripoli dating from 2017 under which it provides training and funding to the coastguard to stem departure of refugees and return to Libva of those already at sea.

However, human rights groups have expressed grave concern pointing out that the policy pushes thousands of refugees back to Libya to face torture and abuse under arbitrary detention.

What has irked some of Starmer's own party colleagues is his remark that he believes prevention and stopping people travelling in the first place is one of the best ways to deal with this particular issue. Since the start of the year, refugee arrivals to Italy by sea have dropped markedly, according to the Ministry of Interior. From 1 January to 13 September, a total of 44,675 people arrived compared with 125,806 for the same period in 2023.

Starmer sought to describe his plan to learn a thing or two from Italy on the immigration question for a pragmatic British approach. Whether it is Labour or Conservative, the UK government, understandably, has to be committed to strengthen the country to be a safe and secure abode for its own citizens. The ideas of humane immigration policies need a proper overhaul and thinking. This is something that has been badly missing in the British Isles in the past. Whereas Meloni's brand of politics that fights immigration tooth and nail and discourages neighbouring nations from pushing Moslem immigrants is totally un-

Meloni's radical right appears to be least bothered about criticism of its anti-immigration policy. This is borne out by the fact that she has defended Matteo Salvini who is on trial for refusing to allow an NGO boat containing 147 migrants to dock in Lampedusa in 2019. He is now a senior member of Meloni's government. Just prior to Starmer's trip, Prosecutors requested a six-year jail sentence for Salvini in the case. Since assuming office two years ago. Meloni has pursued the same agenda as Salvini, but with greater efficiency.

Labour is right to emphasise the need for cross-border collaboration in tackling human trafficking gangs. Western European governments are expected to also respond with compassion to the various crises in the Middle East, many of which were born out of the attitude of the same people now fleeing their own homes. The other aspect is the immigrants, once settled in their adopted country, do not modify their own habits. They are often resorting to disorderly behaviour and violence just to put their Islamist stamp on everything. This will certainly pave the way for the disintegration and destruction of everything that Europe has stood for, from the times of the Crusaders who fought

To consider Meloni is no role model for modern day Europe may be reading the future wrong.

SUSTAINABLE BIOECONOMY

THE WORLD BIOECONOMY FORUM ESTIMATES THE CURRENT VALUE OF THE GLOBAL BIOECONOMY AT \$4 TRILLION, WITH SOME **PROJECTIONS SHOWING THAT THIS COULD RISE TO \$30 TRILLION OR MORE BY 2050**

he world economy con tinues to over-exploit nature, despite being fully dependent on it. It is easy to see why this is unsustainable, especially in light of dangerously escalating climate change. With the biodiversity financing gap estimated to be about \$700-900 billion per year, calls are growing ahead of October's United Nations Biodiversity Conference in Cali, Colombia (COP16) to "invest in

But these well-meaning efforts miss the bigger picture. Investing in nature will not save it so long as the global economy consumes more natural resources than the planet can sustain. It is like trying to shift to a low-carbon economy by using expensive carbon-storage schemes, while simultaneously allowing fossil fuel-intensive industries to emit ever more greenhouse gases.

Instead, what is needed is a regenerative global economy that preserves and restores nature and, in so doing, helps the world achieve crucial climate goals. In short, we must work toward a sustainable and equitable bioeconomy.

The bioeconomy comprises a wide range of sectors and business activities. Most obvious are regenerative forms of agriculture, fishing, forestry, and aquaculture. There are also the many ways that technology is combined with land- and seabased production, from biobased plastics to bioenergy and biopharmaceuticals. Lastly, there are the many opportunities to financialize nature's value through high-integrity and equitable nature-based carbon and biodiversity credits.

The potential is enormous. The World Bioeconomy Forum estimates the current value of the global bioeconomy at \$4 trillion, with some projections showing that this could rise to \$30 trillion or more by 2050. But the bioeconomy is not automatically sustainable or equitable. It can destroy nature, such as through overfishing and deforestation. Similarly, it can deepen inequalities: land grabs

by foreign investors have already been reported, leaving nature-rich countries and local communities in the Global South worse off.

For example, one major question on the biodiversity agenda is how to ensure fair sharing of the profits earned from the digital sequencing of genetic resources. DNA sequence data called "digital sequence information" (DSI) in policy circles have revolutionised the life sciences and are fueling innovation in sectors such as food security, medicine, green energy, and biodiversity conservation. Open access to the SARS-CoV-2 viral sequences was partly responsible for the rapid development of diagnostic kits and vaccines.

DSI also has many commercial applications and offers new opportunities for economic development. It is promising that negotiators recently agreed on a draft recommendation for operationalising the fair and equitable sharing of benefits from DSI, including the creation of a global fund, to be considered

Brazil, in its current role as G20 president, has taken the lead in advancing an equitable,

sustainable bioeconomy. This includes establishing the G20 Initiative on Bioeconomy, which recently defined ten voluntary high-level principles that will help policymakers cultivate a bioeconomy that promotes social inclusion, provides sustainable jobs, and accelerates progress toward climate and nature goals. There are high hopes that Brazil will continue this work during its presidency of the UN Climate Change Conference in 2025, and that South Africa will advance a similar agenda when it assumes the G20 presidency at the end of the year.

Several steps can be taken now to facilitate investment in the bioeconomy. Creating common measurement standards and natural capital accounting could help agencies like UN Trade and Development and the World Trade Organization improve bio-trade arrangements and address subsidy problems. Nature pricing could help drive investment by increasing the economic value of a sustainable bioeconomy. Devising trade and investment rules, addressing data shortfalls, and ensuring systematic analysis are vital

for developing a robust bioeconomy. Regional groups such as the European Union and the African Union are well-positioned to begin implementing these changes.

Developing a successful bioeconomy requires an integrated approach, and that starts with enabling policies. Regenerative agriculture, like bioplastics and bioenergy, struggles to compete with carbon-intensive alternatives that often receive significant subsidies. "Bio-businesses" that rely heavily on technology need a supportive ecosystem of business partnerships, research and innovation, regulation, and public financing that is often lacking in low- and middle-income countries.

Such challenges make it harder for Global South countries to advance value-adding sectors that sustainably use their natural assets. Moreover, while several governments are increasingly developing bioeconomy strategies, sovereigndebt crises, and the resulting fiscal pressures, are often a barrier to unlocking domestic public finance or crowding in private investment.

Development finance institutions can and do play an important role in the Global South. In 2024, for example, the International Finance Corporation committed \$56 billion to private companies and financial institutions in developing countries. But many of these institutions lack a bioeconomy strategy or focus, even though investing in the equitable and sustainable use, conservation, and regeneration of natural resources can protect biodiversity, ramp up climate action, generate decent jobs, and accelerate the uptake of clean tech. Realising these opportunities requires more than one investment at a time. Only by coupling national and regional strategies with international cooperation can we build the sustainable, equitable bioeconomy we need.

Undercurrent of violence

Sir, This refers to "Trump survives 2nd assassination attempt," Orissa POST, Sept 17. Twice within two months, America has narrowly avoided the tragedy of seeing a major political figure assassinated during an election season — and the toxic forces that such an outrage could unleash in a country wracked by visceral partisan divides. That such incidents happen at all speak of the undercurrent of violence that is a constant shadow over American politics, one that is exacerbated by the easy availability of firearms. Both the nominees Donald Trump and Kamala Harris now address outdoor crowds from behind bulletproof screens. There will now be fresh fears that a tempestuous period running up to the election day could take the country further down a dark road. The nearmiss for Trump comes at a moment when the race with Harris is neck-and-neck. While both candidates are fighting over perhaps several hundred thousand movable voters in swing states, it's not clear how much room remains for changing perceptions about Trump, who has been a polarising figure. The former president is all but certain to use the latest events to reinforce his baseless claim that he's a victim of persecution meant to keep him from power. But it's too early to say whether the second apparent assassination attempt will have greater political impact than the first.

Thiruvananthapuram, Sept 17: Kerala Health Minister Veena George said Tuesday that 16 people who came into contact with a 24-year-old man, who died of Nipah virus in Malappuram district last week, have tested negative for the disease.

Of the total 225 people on the contact list of the deceased, the samples of 16 people in the high risk category, tested negative at the Manjeri Government Medical College in Malappuram, she told reporters here.



At present, there are 50 people in the high risk category, George said, adding that 77 people on the contact list were health workers.

The minister, who conducted an evaluation meeting in the morning and evening to take stock of the situation, said there is no room for any concern as of

She said the Health department is taking all possible steps to check the spread of the disease by identifying a maximum number of persons who have come into contact with the man, and administering them preventive

'The samples of those in the high risk category and the persons showing any symptoms are being collected and sent for testing. Samples of more people will be collected today," she said.

Though the chance of any spread of the disease is unlikely, the samples of every person showing symptoms would be

George further said the state government has been in constant contact with the Centre and the health authorities in Karnataka where the deceased man was studving.

Disclosing report might jeopardise probe: SC

New Delhi, Sept 17: The Supreme Court Tuesday said it was disturbed by the findings given in a status report filed by the Central Bureau of Investigation (CBI) in the rape and murder of trainee doctor at R G Kar government hospital in Kolkata but refused to divulge the details, saying any disclosure may jeopardise the ongoing investigation.

Seeking a status report from the CBI on its probe into financial irregularities allegedly committed by jailed former principal of R G Kar Medical College and Hospital Sandip Ghosh, the top court, referring to the rape and murder case, said the agency is not "sleeping over" the investigation and it needs to be given time to "unearth the truth."

What the CBI has revealed in the report is really disturbing. What you are flagging is of utmost concern. We ourselves are concerned, CBI has flagged it for us. We are ourselves disturbed by what we have read," the top court told a lawyer who claimed discrepancies in the seizure list and sketch of the crime scene.

A bench comprising Chief Justice D Y Chandrachud and Justices JB Pardiwala and Manoj Misra also asked the protesting iunior doctors in West Bengal to resume work and recorded the assurance from the state government that it will not take any adverse or punitive action against them. Taking note of a letter written by the father of the deceased, the top court directed that the "valuable" inputs



furnished by him should be duly considered by the investigating

Solicitor General Tushar Mehta, appearing for the CBI, assured the court that the investigating agency

will maintain contact with the parents of the deceased junior doctor and keep them informed about the ongoing probe to assuage their genuine concerns.

As the hearing commenced, senior advocate Kapil Sibal, appearing for the West Bengal government, sought stopping of the live proceedings in the case. He alleged that women lawyers working in his chamber were facing threats of acid attacks and rape.

"I have great concerns at what is happening. What happens when you livestream matters like this which has huge emotive implications. We are not representing the accused. We appear for the state government and as soon as the court is making a comment our reputation is getting destroyed overnight. We have 50 years of reputation,'

The top court assured Sibal it would step in if there were any threats to lawyers and others "We will not stop the live streaming of the proceedings. It is in public interest," the bench said.

During the hearing, the apex court took objection to the West Bengal government's 'Rattierer Saathi' programme which prescribes night duty avoidance for women doctors and says that their duty should not exceed 12 hours at a time.

The top court also questioned the West Bengal government's decision to hire contractual employees for the protection of doctors and other staff in hospitals. Senior lawver Indira Jaising said junior doctors know the people who were at the scene of the crime and the information shall be shared with the CBI in a sealed cover. Meanwhile, Solicitor General Tushar Mehta, appearing for the CBI, submitted that Wikipedia was still showing the name and photo of the victim. The top court then directed Wikipedia to remove all content that identified the victim.

'Can't stop women docs from working at night'

The Supreme Court Tuesday objected to the West Bengal government's 'Rattierer Saathi' programme which stipulated that working hours of women should not exceed 12 hours at a time and prescribed avoiding night duty. A bench comprising Chief Justice D Y Chandrachud and Justices J B Pardiwala and Manoj Misra expressed surprise that the state government has issued such a notification. The top court said if men are working in more that 12-hour shift, women doctors are also entitled to do so. "How can you say that women will not work in night shifts? Women will have objection if you stop them from working in the night," it said. The court ordered that the West Bengal government should immediately correct the notification.

Remove name, photo of victim; SC to Wikipedia

The Supreme Court Tuesday directed free online encyclopedia Wikipedia to remove the photograph and name of the resident doctor. A bench headed by Chief Justice D Y Chandrachud took note of the submission by Solicitor General Tushar Mehta who said Wikipedia was still carrying the name and the photograph of the victim. The top court said provisions of the law are very clear that the identity of the victim in rape and murder cases cannot be revealed. "In the interest of maintaining dignity and privacy of the deceased, the governing principle is that identity of victim in a rape and murder case shall not be disclosed. "Wikipedia shall take steps to comply with the previous order passed," the bench, also comprising Justices J B Pardiwala and Manoj Misra, said.

Cong slams 100 days of Modi 3.0

New Delhi, Sept 17: The Congress Tuesday claimed that the first 100 days of Modi 3.0 was marked by a litany of U-turns and a series of scandals with the government yet again having "failed to act" on India's "mass unemployment crisis".

Congress general secretary in-charge communications Jairam Ramesh "the non-biological PM and his drumbeating economists" have consistently attacked the idea of jobless growth but the reality of what has been seen since 2014 is perhaps even more stark --"job-loss growth"

"Yesterday marked a hundred days of this unstable, crisis-ridden Government, Amidst a litany of u-turns and a series of scandals, the government has yet again failed to act on India's mass unemployment crisis – an issue which the Congress has been consistently sounding the alarm on for the past five years at least," he said in a statement.

The crisis has been of the government's own making, caused by the decimation of job creating MSMEs through the "Tughlakian demonetisation", a hastily rushed through GST, an unplanned COVID-19 lockdown and rising imports from China, Ramesh said.

'The final straw has been the non-biological PM's economic policy of favouring large conglomerates. India's unemployment rate today is the highest it has been in 45 years, with the unemployment rate for graduate youth at 42%," he said. Ramesh said there is an abundance of data proving the extent of this crisis, and two damning trends stand out - failure to create sufficient employment and shrinking of formal salaried jobs.

The International Labour



Employment Report, 2024, finds that each year, around 70-80 lakh youths are added to the labour force but between 2012 and 2019 there was almost zero growth in employment – just 0.01%,

the senior Congress leader said. The same report found that in 2022, unemployment was very high among the urban youth (17.2 per cent) as well as rural youth (10.6 per cent), he pointed out and added that the female unemployment rate in urban areas was extremely high at 21.6 per cent.

A report by Citigroup projected that India must create 1.2 crore jobs per year for the next 10 years to employ our youth, Ramesh said. In fact, the natural corollary

of the shrinking of formal sector salaried jobs is an increase in low-wage, informal jobs - an economic travesty that the RBI KLEMS is capturing, and the government is proudly touting, he said.

Congress general secretary (organisation) K C Venugopal said, "As we look back at the 100 days of the NDA government, we see a whole host of disasters. reversals and a directionless government that is completely failing the people of India."

There is still no vision to solve the unemployment crisis, rural distress or skyrocketing price rise that the ordinary citizen is suffering from, Venugopal said.

TOP COURT CLOSES CASE AGAINST 30 ARMYMEN

New Delhi, Sept 17: In a relief personnel, the Supreme Court Tuesday closed the criminal proceedings initiated against them by the Nagaland government for allegedly killing 13 civilians in a 2021 botched operation to ambush militants in Mon district for want of prosecution sanction.

A bench of Justices Vikram Nath and PB Varale noted that the Centre had February 28 last year declined to grant sanction to prosecute the personnel under section 6 of the Armed Forces (Special Powers) Act (AFSPA) of 1958. Section 6 of the AFSPA says, "No prosecution, suit or other legal proceedings shall be instituted except with the previous sanction of the

Central Government, against any person in respect of anything done or purported to be done in exercise of the powers conferred by this Act."

The bench said, in case sanction is granted at any stage under Section 6 of the AFSPA, the proceedings pursuant to the impugned FIRs may continue and may proceed in accordance with law and be brought to a logical conclusion. "In view of the aforesaid discussions, the writ petition (Criminal) Nos...are allowed," the bench directed.

The apex court closed the proceedings on two separate petitions filed by the wives of the personnel, including a major rank officer, who sought closure of the case lodged by Nagaland

'Antibiotic resistance to claim over 39mn lives by 2050'

Future deaths from antibiotic resistance are estimated to be highest in South Asia -- including India, Pakistan and Bangladesh -- where a total of 11.8 million deaths directly due to it are forecast between 2025 and 2050, a collaboration of researchers forming the Global Research on Antimicrobial Resistance (GRAM) Project said

New Delhi, Sept 17: Over a million people around the world died annually due to antibiotic resistance between 1990 and 2021, and more than 39 million could die from antibiotic-resistant infections over the next 25 years, according to a global analysis, published in The Lancet journal.

Antibiotic, or antimicrobial, resistance is when drugs designed to kill infectious bacteria and fungi are rendered ineffective because the bugs have evolved and developed an ability to defeat these drugs. The researchers said deaths due to antibiotic resistance will also be high in other parts of southern and eastern Asia and sub-Saharan Africa.

and 2021 suggested that among people aged 70 years and above, deaths caused by antibiotic resistance increased by more than 80 per cent, and will continue to affect older people more in the years to come, the authors Further, trends between 1990 said. Over the same period,

deaths due to antibiotic resistance among children aged under five years fell by more than 50 per cent, they found.

"The fall in deaths from sepsis (a bloodstream infection) and antibiotic resistance among young children over the past three

decades is an incredible achievement. However, these findings show that while infections

have become less common in young children, they have become harder to treat when they occur," author Kevin Ikuta, an affiliate professor at the Institute of Health Metrics (IHME), University of Washington, US, one of the collaborators on the GRAM Project, said.

An improved access to health care and antibiotics could save a total of 92 million lives between 2025 and 2050, the authors estimated. The study is the first global analysis of antimicrobial resistance trends over time, they said. An increasing resistance to antibiotics -- one of the "cornerstones of modern healthcare" -- is a major cause for concern and the findings highlighted the significance of the global health threat, according to author Mohsen Naghavi from the IHME.

The analysis was based on data from 520 million people of all ages in 204 countries and territories, taken from a wide range of sources, including hospital and death records, and antibiotic use information.

The estimates produced are related to 22 disease-causing microbes (pathogens), 84 pathogendrug combinations and 11 infectious symptoms such as bloodstream infections, the authors said. In 2019, deaths related to antibiotic resistance were higher than those from HIV/AIDS or malaria, leading directly to 1.2 million deaths and playing a role in a further nearly five million deaths, according to the first study by the GRAM Project, published in 2022.

Malappuram (Kerala), Sept 17: A suspected case of monevpox infection has been reported from Malappuram district of Kerala after a man who recently returned from Dubai showed symptoms of the disease.

State Health Minister Veena George said that the man on noticing the symptoms had taken precautionary measures by isolating himself from his family and was currently hospitalised in the Manjeri Medical College here.

"His samples have been sent for testing and the results are awaited," the minister said..

Earlier in the day, a district health official said that the patient arrived in Kerala a few days ago and, after falling sick, was first admitted to a private hospital. "From there he was admitted to the Manjeri Medical College. On suspecting that it might be a case of monkeypox, we sent his samples to the Kozhikode Medical College for testing. The results are awaited,' the official said.

A new case of monkeypox (Mpox) was reported last week from the national capital after a 26-year-old resident of Haryana's Hisar tested positive for the virus and was admitted to Delhi government-run LNJP Hospital.

The Union Health Ministry had termed it an isolated case, similar to the earlier 30 cases reported in India from July 2022 onwards and said that it was not part of the current public health emergency reported by WHO which is regarding clade 1 of mpox, it underlined. The 26-yearold Hisar native tested positive for mpox virus of the West African clade-2, it had said. The World Health Organisation (WHO) last month declared mpox a Public Health Emergency International Concern (PHEIC) for the second time in view of its prevalence and spread across many parts of Africa. Mpox infections are generally self-limiting, lasting between two and four weeks, and its patients usually recover with supportive medical care and management.

Tight slap on face of hate-filled CMs: Cong

THE OPPOSITION PARTY ASSERTED THAT BULLDOZER HAS BECOME A SYMBOL OF HATE. VIOLENCE AND POLITICAL VENDETTA

New Delhi, Sept 17: The Congress Tuesday welcomed the Supreme Court directive against "bulldozer justice", saying it is a "tight slap" on the face of hatefilled Chief Ministers and leaders who were encouraging it.

The Opposition party also asserted that bulldozer has become a symbol of hate, violence and political vendetta. Even if there is one instance of illegal demolition, it is against the ethos of our Constitution, the Supreme Court said Tuesday while directing that authorities across the country will not demolish properties, including those accused of crime, till October 1 without seeking its permission.

A bench of Justices B R Gavai and K V Viswanathan clarified that its order will not be applicable to unauthorised structures on public roads, footpaths and the likes. In a post in Hindi on X, Congress general secretary Priyanka Gandhi Vadra said, "The decision of the Supreme Court holding a mirror to the unjust and inhuman 'bulldozer policy' of the BJP governments is welcome.'

Through such barbaric actions, the policy and intentions of trampling humanity and justice by 'running a bulldozer over the law of the country' have been exposed before the entire country," she said. They believe that under the guise of "instant justice", the rule of mob and fear can be established by crushing the Constitution with the bulldozer of oppression and injustice, Priyanka Gandhi said.

"But this country is run by the Constitution and will run only by the Constitution. The court has made it clear that 'bulldozer



injustice' is not acceptable." she said. Reacting to the development, Congress spokesperson Supriya Shrinate said the Supreme Court has made it clear that the country will be run by the Constitution and not by bulldozer and anarchy.

"The Suprme Court's assertion that bulldozer will not be allowed till guidelines are framed is a tight slap on the face of hatefilled CMs and leaders who were encouraging bulldozer justice by putting a lock on courts,' she said in a video statement posted on X.

"Bulldozer has become a symbol of hate, violence and political vendetta. Bulldozer means fanning a storm of hatred against one community, one section. We welcome this verdict and hope that after this. UP Chief Minister (Yogi Adityanath) will not challenge the Supreme Court to keep his bulldozer running and there will be a ban on bulldozer justice of copycats in Chhattisgarh, Madhya Pradesh

and Maharashtra," she said. Shrinate asserted that bulldozer has no place in a civilised



society and is used by anarchic elements and goons, not elected chief ministers.

The top court's directive came over petitions alleging properties of those accused of crime were being illegally demolished in several states. Solicitor General Tushar Mehta told the bench that a "narrative" was being built over the demolition of properties. He said there was a petition before the apex court which alleged that because the person belonged to a particular religion, his property was demolished.

The bench also expressed its displeasure over the statements made after the September 2 hear ing in the matter during which the apex court had said it proposes to lay down certain guidelines on the issue that would be enforceable across the country "After that order, there have been statements that the bulldozer will continue... and it all depends in whose hands the steering is," the bench said. It said such statements were made and the court was refraining from saying anything further on that.

The 'meteoric' rise of Atishi in politics

New Delhi, Sept 17: From being an adviser to the Delhi government to becoming a key face of the cabinet in the absence of senior AAP leaders. Chief Minister-designate Atishi's ascent in the party and government is believed to be "phenomenal" and "meteoric".

Atishi, 43, who holds the highest number of portfolios in the Delhi government, will also hold the distinction of being only the third woman after Sushma Swaraj and Sheila Dikshit to become the Chief Minister of the national capital. She was unanimously chosen as Chief Minister designate during the legislature party meeting here Tuesday. In her first remarks after being chosen to replace Kejriwal, she thanked him and called him her elder brother.

Crediting the Aam Aadmi Party (AAP), she said it was only possible here that a first-time politician could be given such a huge responsibility. Being chosen just months short of Delhi polls, Atishi has her task cut out. She will have to hold cabinet meetings to approve and fast track key projects and policies like the Mukhyamantri Mahila Samman Yojana and the Electric Vehicle 2.0 Policy among others.

Atishi was a founding member of AAP and played a pivotal role in shaping its policies, including as a key member of the 2013 Manifesto Drafting Committee. Known for her articulate advocacy, she has been a consistent voice for the party's principles.

She spent seven years in a Madhya Pradesh village, focusing on organic farming and progressive education. This experience played a crucial role in strengthening her dedication to political change, according to a party functionary. Even though Atishi joined AAP in 2013, she staved in the background work ing as an adviser to the government on education-related policies and made a foray into



electoral politics only in 2019 when she contested the Lok Sabha polls from East Delhi against BJP's Gautam Gambhir. only to taste defeat

Before venturing into active politics, Atishi had dropped her surname Marlena, a portmanteau of Marx and Lenin, since she wanted that her political affiliations should not be misconstrued. In the lead upto the 2019 elections, she had accused the BJP candidate of slandering her and distributing pamphlets containing "obscene" remarks about her, which had even led her to breaking down at a press conference.

In 2020, Atishi again contested elections, this time the Delhi Assembly polls, and was elected as an MLA from Kalkaji. She was inducted into the Cabinet at a time when the government was staring at a crisis in the aftermath of arrest of Manish Sisodia in February last year in the excise policy case.

While Sisodia and Kejriwal were in jail, Atishi not only took care of governance but also defended the government and the party whenever it was on a sticky wicket. Be it at the time of Delhi water crisis or when party's Rajya Sabha MP Swati Maliwal alleged assault by Kejriwal's aide Bibhay Kumar, she vehemently thwarted the criticism by the Opposition parties.

Flood-like situation in Bengal; two dead

Kolkata, Sept 17: Two persons have died as the flood-like situation in several districts in the southern part of West Bengal remained grim Tuesday following heavy rain and consequent rise in water discharge from barrages within a short span of time, a senior state official said

Parts of Birbhum, Bankura, Howrah, Hooghly, North and South 24 Parganas, Purba and Paschim Medinipur, Paschim Bardhaman districts are inundated, the CM's Chief Advisor, Alapan Bandyopadhyay, said. While one person died due to wall collapse following rain in Purba Bardhaman district, another died of electrocution in Hooghly district since Monday.

Due to heavy rainfall, 1,33,750 Cusec of water was released from Durgapur Barrage, 40,000 cusec from Kangsabati dam, 2.00.000 cusec from Maithon dam and 50,000 cusec from the Panchet Dam in the last 24 hours. Bandyopadhyay said very heavy rainfall was reported at Baghmundi (134.20 mm) in Purulia district, while heavy rainfall was recorded at Bhairabbanki (90.4 mm) and Mukutmanipur (90.6 mm) in Bankura, Kharidwar (106.4 mm) in Purulia, Gopiballavpur (90 mm) of Jhargram districts since Monday.

The Rupnarayan, Dwarakeswar, Shilabati, Kaliaghai, Kalapaleswari rivers are flowing above the extreme danger level, he said. Disaster Relief Teams from the Centre and the state are working at Hooghly, Paschim Medinipur, South 24 Parganas, Howrah and some other places.

Bandyopadhyay said 17 state disaster relief teams are currently working in parts of Hooghly, Bankura, Paschim Medinipur, North 24 Parganas, Howrah and Purba and Purba Medinipur districts.

Land-for-jobs 'scam': HC grants bail to Lalu's aide

New Delhi: The Delhi High Court Tuesday granted bail to RJD chief Lalu Prasad's close aide Amit Katval in a money laundering case linked to the alleged land for-jobs scam in the Indian Railways, while deprecating the "pick and choose" policy adopted by the Enforcement Directorate (ED). The court noted that despite there being no arrest of any other accused in the case and irrespective of the fact that Katyal had joined the probe, he was arrested unceremoniously from the Indira Gandhi International Airport while he was travelling to Ranchi.

Excise policy: HC grants bail to Amit Arora, AS Dhall

New Delhi: The Delhi High Court Tuesday granted bail to businessmen Amit Arora and Amandeep Singh Dhall in a money laundering case related to the alleged excise policy scam, paving the way for the release of all the accused being prosecuted in the matter. In the main corruption case being probed by the Central Bureau of Investigation (CBI), several key accused, including AAP chief Arvind Kejriwal, former Deputy Chief Minister Manish Sisodia and BRS leader K Kavitha are on bail, "Bail granted," said Justice Neena Bansal Krishna while granting relief to the two accused. Arora and Dhall, According to the Enforcement Directorate (ED) and the CBI, irregularities were committed while modifying the Delhi Excise Policy 2021-22 and undue favours extended to licence holders.

SC rejects plea to relax advocates' dress code

New Delhi: The Supreme Court Tuesday refused to entertain a PIL seeking exemption for lawyers from wearing black coat and gown in courts during summer, saving there has to be some dress code and they cannot wear 'kurta-payiama', a traditional Indian outfit of a loose-fitting tunic. "Ultimately it is a matter of decorum. You should be properly attired. You have to wear something. You cannot argue in 'kurta paiyama' or shorts and T-shirt also...," said a bench comprising Chief Justice D Y Chandrachud and Justices JB Pardiwala and Manoj Misra.

2 YEARS OF PROJECT CHEETAH

New Delhi, Sept 17: Several promising births, fewer but painful losses, growing optimism and some criticism marked the second year of the internationally acclaimed Project Cheetah, which looks ahead with renewed hope and ambition amid many challenges.

As the grand initiative completes two years Tuesday, authorities are speeding up efforts to bring in a new batch of cheetahs from Africa to the Gandhisagar Wildlife Sanctuary, which will be their second home in India, and setting up a conservation breeding centre in the Bunni grasslands in Gujarat.

They also aim to establish a larger cheetah habitat, spanning the territorial divisions of

Neemuch (about 1,000 sq km) and Mandsaur (500 sq km) in Madhya Pradesh, along with the Bhainsrorgarh Wildlife Sanctuary (208 sq km) and Chittorgarh (around 1,000 sq km) in Rajasthan.

In a major boost to the project, 13 cubs were born on Indian soil in the second year, though two of them did not survive. Namibian cheetah Aasha gave birth to three cubs in January. Another female from Namibia, Jwala, also had three cubs that month. Jwala had delivered four cubs last year, but only one survived. South African cheetah Gamini had six cubs in March, bringing the total number of cubs to 13 this year.

Two adult cheetahs, Namibian males Shaurya and Pawan, died this year. Pawan was the only



cheetah roaming freely in Kuno National Park. Shaurya died of septicemia in January, and Pawan died in August due to "drowning". Experts say

cheetahs generally do not drown. While authorities have been busy preparing the 368-sq km Gandhisagar Wildlife Sanctuary for the next batch of cheetahs, the ones in Kuno remain inside enclosures that are only 0.5 to 1.5 square kilometers in size.

For context, cheetahs need much larger areas in the wild. usually over 50 square kilometers, depending on prey availability.

Ravi Chellam, CEO of Metastring Foundation and Coordinator, Biodiversity Collaborative, said that according to global experience and Namibian laws and policies, it is not a good idea to release



Hezbollah hit by exploding pager

AT LEAST NINE PEOPLE WERE KILLED AND DOZENS OF PEOPLE WERE WOUNDED IN BEIRUT'S SUBURBS AND OTHER PARTS OF LEBANON AFTER THEIR HANDHELD PAGERS EXPLODED

Beirut, Sept 17: Pagers used by hundreds of members of the militant group Hezbollah exploded near simultaneously in Lebanon and Syria Tuesday, killing at least nine people, including an 8-year-old girl, and wounding several thousand, officials said. They blamed Israel in what appeared to be a sophisticated, remote attack.

Among those wounded was Iran's ambassador to Lebanon. The mysterious incident came amid rising tensions between Israel and Iran-backed Hezbollah, which have exchanged fire across the Israel-Lebanon border since the October 7 attack by Hamas that sparked the war in Gaza.

The pagers that exploded had been newly acquired by Hezbollah after the group's leader ordered members to stop using cell phones, warning they could be tracked by Israeli intelligence. A Hezbollah official told The Associated Press the pagers were a new brand the group had not used before.

At about 330 pm local time Tuesday, pagers started heating up and then exploding in the pockets and hands of those carrying them, particularly in a southern Beirut suburb and the Begaa region of eastern Lebanon where Hezbollah has a strong presence, and in Damascus, where several Hezbollah mem-

bers were wounded. Lebanese security officials and a Hezbollah official said.

The AP reached out to the Israeli military, which declined to comment. The explosions came hours after Israel's internal security agency said it had foiled an attempt by Hezbollah to kill a former senior Israeli security official using

a planted explosive device that could be remotely detonated. It targeted an extraordinary

breadth of people with hundreds of small explosions, all at once, wherever the pager carrier happened to be, that left some maimed.

Lebanon's health minister, Firas Abiad. said at least nine people were killed, including an 8-year-old girl, and 2,750 wounded, 200 of them critically, by the explosions. Most had iniuries in the face, hand, or around the abdomen.

Hezbollah said in a statement

among those killed. The Hezbollah official who spoke anonymously identified one of the dead as Mahdi Ammar, the son of one of the group's members in the Lebanese Parliament.

"We hold the Israeli enemy fully responsible for this criminal aggression that also targeted civilians," Hezbollah said, adding that Israel will "for sure get its just punishment."

Iranian state-run IRNA news agency said that the country's ambassador, Mojtaba Amani, was superficially wounded by an exploding pager and was being treated at a hospital.

The images seen Tuesday showed signs of detonation, said Alex Plitsas, a weapons expert at the Atlantic Council. "A lithium ion battery fire is one thing, but I've never seen one explode like that. It looks like a small explosive charge," Plitsas

Israel has a long history of carrying out deadly operations behind enemy lines.

It is pertinent to note that rather than implement UN Security Council resolution 1559 that requires the Lebanese government to disarm all militias in Lebanon (including Hezbollah), or the implementation of Security Council resolution 1701 that requires that Hezbollah stay north of the Litani river, the Lebanese government announced that it is headed to the UN Security Council to sanction Israel.

AMID RUSSIAN BAN

US PROBES CHINESE URANIUM IMPORTS

Washington, Sept 17: President Joe Biden's administration is probing a surge in imports of enriched uranium from China since late 2023 amid concerns the shipments are helping Moscow sidestep a US ban on imports of the power plant fuel from Russia, Reuters has learned.

US House lawmakers passed the ban on Russian enriched uranium in December 2023 as part of a US effort to disrupt President Vladimir Putin's abilitv to fund Russia's war on Ukraine.

That month, shipments of enriched uranium from China to the US shot to 242,990 kilograms, according to data from the US International Trade Commission. The imports are significant because from 2020 to 2022 China did not send any enriched uranium to the US.

In May this year, the month that Biden signed the ban, China again sent the US a large amount of uranium, this time totaling 123,894 kilograms.

The US Department of Energy

"along with other relevant agencies is closely tracking imports from China to ensure the proper implementation of the recently enacted Prohibiting Russian Uranium Imports Act," a department spokesperson said, a development that has not been previously reported.

US officials are watching the imports from China and other countries to "ensure they are not importing Russian uranium as part of a scheme to export material produced domestically that they would otherwise have used in their own reactors," the spokesperson said.

There was no immediate response from the Chinese foreign ministry in Beijing to a request for comment. Russia is the world's largest ex-

porter of enriched uranium. Imports to the US from Russia through July this year stood at 313,050 kilograms, down 30% from last year. The ban allows some Russian imports to continue until 2028 if there are supply concerns.

Any circumvention of the ban could undermine the US effort to eventually eliminate dependence on Russian fuel for its nuclear power industry, the biggest in the world. It could also weaken the Biden administration's attempts to jumpstart a domestic uranium supply chain, as the ban unlocked \$2.72 billion in public funds to do so.

But major political parties, including the BNP, which is headed by former Prime Minister Khaleda Zia, want the new election sometime soon

Yunus took the helm after former Prime Minister Sheikh Hasina fled the country during a mass uprising last month, ending a 15-year spell in power. The protests began in July and morphed into an anti-government

Hasina has been living in India since. In his recent speeches, Yunus hasn't outlined when a new national election would be held and said they would stay in power as long as the people want them to stay.

A team of newspaper editors recently said that Yunus should complete crucial reforms first and stay in power for at least

The BNP initially demanded an election in three months, but later said it wants to allow the interim government time for reforms. The country's main Islamist Jamaat-e-Islami party, which was once officially an alliance partner under Zia's party, also wants to give the Yunus-led government more time before

Tarique Rahman, heir apparent to Zia and the BNP's acting chairman, spoke online from London where he has been living in exile since 2008. He said Tuesday that his party supported the interim government's plans for reforms, but such changes would only be sustained if the people have their say in the

He didn't specify when a new election should be held, but said any reforms must be endorsed in the next Parliament

Meta bans Russia state media outlets

LONDON: Meta said it's banning Russia state media organisation from its social media platforms, alleging that the outlets used deceptive tactics to amplify Moscow's propaganda. The announcement drew a rebuke



from the Kremlin Tuesday. The company, which owns Facebook, WhatsApp and Instagram, said late Monday that it will roll out the ban over the next few days in an escalation of its efforts to counter Russia's covert influence operations. "After careful consideration, we expanded our ongoing enforcement against Russian state media outlets Rossiya Segodnya, RT and other related entities are now banned from our apps globally for foreign interference activity", Meta said in a prepared statement. Kremlin spokesman Dmitry Peskov lashed out, saying that "such selective actions against Russian media are unacceptable," and that "Meta with these actions are discrediting themselves."

Venezuela ramps up repression after disputed vote

CARACAS: President Nicolas Maduro's government escalated repressive tactics to crush peaceful protests and keep power after Venezuela's disputed election in July, a UN report said Tuesday. Electoral authorities



awarded the vote to Maduro, without showing all tallies, but the Opposition said its candidate Edmundo Gonzalez won by a landslide with counts proving that. The UN fact-finding mission, which interviewed several hundred people remotely or in third countries as it is denied access to Venezuela, said authorities tried to dismantle the Opposition, block independent information, and stop protests. "We are facing a systematic, coordinated and deliberate repression by the Venezuelan government, which responds by a conscious plan to silence any form of dissent," mission head Marta Valinas told journalists in Geneva.

Palestinian poll finds big drop in support for Oct 7 attack

THE POLL, CONDUCTED IN EARLY SEPTEMBER BY THE PALESTINIAN CENTER FOR POLICY AND SURVEY RESEARCH, FOUND THAT 57% OF PEOPLE SURVEYED IN THE GAZA STRIP SAID THE DECISION TO LAUNCH THE OFFENSIVE WAS INCORRECT, WHILE 39% SAID IT WAS CORRECT

Ramallah, Sept 17: A majority of Gazans believe Hamas' decision to launch the October 7 attack on Israel was incorrect, according to a poll published Tuesday pointing to a big drop in backing for the assault that prompted Israel's devastating Gaza offensive.

The poll, conducted in early September by the Palestinian Center for Policy and Survey Research (PSR), found that 57% of people surveyed in the Gaza Strip said the decision to launch the offensive was incorrect, while 39% said it was correct.

It marked the first time since October 7 that a PSR poll found a majority of Gazan respondents judging the decision as incorrect. It was accompanied by a drop in support for the attack in the West Bank, though a majority of 64% of respondents there still thought it was the correct decision, the poll found.

PSR's previous poll, conducted in June, showed that 57% of respondents in Gaza thought the decision to be correct.

More than 41,000 Palestinians have been killed by the Israeli military offensive that has laid waste to the Gaza Strip since last October, according to the Gaza health ministry.

Israel launched its assault after the unprecedented Hamas raid which killed 1,200 people and resulted in another 250 being abducted, according to Israeli tallies.



PSR said it surveyed 1,200 people face-to-face, 790 of them in the West Bank and 410 in Gaza, with a 3.5% margin of error.

PSR polls since the October 7 attack have consistently shown a majority of respondents in both Gaza and the West Bank to believe the attack was a correct decision, with support generally greater in the West Bank than Gaza.

PSR said the poll released Tuesday marked the first time since October 7 that its findings had shown simultaneously in the West Bank and Gaza a significant drop in the favorability of the attack and in expectations that Hamas will win the current war.

Overall, the poll found a maiority of 54% of respondents in Gaza and the West Bank thought the decision was correct.

In August, the Israeli military accused Hamas of mounting an effort to falsify the results of PSR polls to falsely show support for Hamas and October 7, though the military said there was no evidence of PSR cooperating with Hamas.

PSR said it had taken the allegation seriously and investigated it. PSR said Tuesday its analysis of the data did not flag

any inconsistencies that would arise when data is arbitrarily altered, and that a review of quality control measures "convinced us that no data manipulation took place" Support for October 7 did not

necessarily mean support for Hamas or killings or atrocities against civilians, PSR said, adding that "almost 90% of the public believes Hamas men did not commit the atrocities depicted in videos taken on that day"

The poll showed a drop in the number of respondents in Gaza who said they support Hamas to 35% from 38%. But the Islamist movement remained more popular than Fatah, led by President Mahmoud Abbas, in both in Gaza and the West Bank.

Trade deficit widens to 10-month high

New Delhi, Sept 17: India's exports registered a steepest decline in 13-month falling 9.3 per cent in August to USD 34.71 billion due to global economic uncertainties, while the trade deficit soared to a 10-month of USD 29.65 billion.

According to the government data released Tuesday, imports increased by 3.3 per cent to USD 64.36 billion, which is a record high, due to a significant jump in the inbound shipments of gold and silver.

While gold imports more than doubled to USD 10.06 billion in August from USD 4.93 billion in the same month last year, silver imports swelled to USD 727 million in the month under review from USD 159 million in August

Due to a decline in petroleum prices, crude oil imports dipped by 32.38 per cent to USD 11 billion. The dip in prices has also impacted the merchandise ex-

The trade deficit, or the gap between imports and exports, in October 2023 was USD 30.43 billion. The merchandise exports in July last year contracted by over 10 per cent.

India's merchandise exports dipped by 1.5 per cent in July.

Exports during April-August this fiscal increased 1.14 per cent to USD 178.68 billion, and imports grew 7 per cent to USD 295.32 billion.



Merchandise trade deficit during April-August 2024 was USD 116.64 billion compared to USD 99.16 billion during April-August

Briefing the media on data. Commerce Secretary Sunil Barthwal said that in the current global situation, exports is a huge challenge

Reasons like slowdown in China and continued recession in the EU and the US too are impacting the exports; dipping oil prices and rise in transportation cost due to the Red Sea crisis are hurting the shipments.

"There are a lot of challenges in trade," Barthwal told reporters

However, he added that despite these issues India's exports during the first five months of this fiscal have registered a positive growth.

Exports of petroleum prod-

ucts declined by 37.56 per cent to USD 5.95 billion during the month.

To further push the shipments of goods, the commerce ministry is focusing on exploring new markets in regions like

Besides, he said, 12 champion services sectors have been identified such as education, health care, shipping, and transportation, to push their shipments as they hold huge opportunities.

'We are focusing on these sectors. If we have to reach the USD 2 trillion exports target of goods and services, 50 per cent will be coming from the services sector," he said, adding that these sectors are not impacted by global

"Despite dark clouds, India is a bright spot," the secretary said. When asked about the high trade deficit, he said it is not a

matter of concern for an emerging economy like India.

He explained that at one point in time, China also maintained larger trade deficits. "There is a huge consumption demand (in India) which is coming from an economy which is growing at double the rate at which the world economy is growing...

"Once you join the global value chains and it gives you forward and backward linkages, you have to import certain things in order to export," he said.

The other export sectors, which have recorded negative growth during the month, include rice, oil meals, marine products, iron ore, and gems and jewellery.

However, electronic goods, pharma and engineering exports rose 7.85 per cent, 4.67 per cent and 4.36 per cent, respectively, in

Wholesale inflation falls to 1.31 per cent in Aug

New Delhi, Sept 17: Wholesale inflation fell for the second consecutive month to 1.31 per cent in August due to cheaper vegetables, food and fuel, government data released Tuesday showed.

The wholesale price index (WPI) based inflation was 2.04 per cent in July. It was (-) 0.46 per cent in August last year.

"Positive rate of inflation in August 2024 is primarily due to increase in prices of food articles, processed food products, other manufacturing, manufacture of textiles and manufacture of machinery & equipment etc," the industry ministry said in a statement.

As per the data, inflation in food items was 3.11 per cent in August against 3.45 per cent in July. This was led by declining prices of vegetables, which recorded a deflation of 10.01 per cent in August compared to 8.93 per cent in July.

Inflation in potatoes and onions continued to be high at 77.96 per cent and 65.75 per cent in August. The fuel and power category witnessed deflation of 0.67 per cent in August against inflation of 1.72 per cent in July.

Data released last week showed retail inflation was at 3.65 per cent in August on higher prices of vegetables.



This was higher than 3.60 per cent in July.

The Reserve Bank of India (RBI), which mainly takes into account retail inflation while framing monetary policy, kept the benchmark interest rate or repo rate unchanged for the ninth consecutive time in August at 6.5 per cent.

India's manufacturing companies have gained after a fall in global commodity prices.Manufactured product prices increased 1.22% yearon-year against a 1.58% rise in the previous month. Fuel and power prices fell 0.67% onyear compared with a 1.72% increase in July, data showed.

Global benchmark Brent crude prices have fallen to below \$75 a barrel from over \$92 a barrel in April, helping major importers like India.

Gold imports doubled to \$10.06bn in August

New Delhi, Sept 17: Gold imports more than doubled in August to a record high of USD 10.06 billion, mainly on account of a drastic cut in customs duty and ongoing festive demand. according to the Commerce Ministry data.

Gold imports stood at USD 4.93 billion in August 2023.

On record high imports, Commerce Secretary Sunil Barthwal said that the tariff rates on gold have been reduced drastically so that smuggling and other activities can come down.

"And this is the time when jewellers start stocking for their inventories to be sold in the festival season," he told reporters. In the Budget, the government

slashed the duty from 15 per cent to 6 per cent.

India's gold imports, which have a bearing on the country's current account deficit (CAD), dipped by 4.23 per cent to USD 12.64 billion during April-July

In 2023-24, India's gold imports surged by 30 per cent to USD 45.54 billion.

Switzerland is the largest source of gold imports, with about 40 per cent share, followed by the UAE (over 16 per cent) and South Africa (about 10 per

The precious metal accounts for over 5 per cent of the country's total imports.

The jump in gold imports pushed the country's trade deficit (difference between imports and exports) to USD 29.65 billion in



India is the world's secondbiggest gold consumer after China. The imports mainly take care of the demand by the jewellery industry.

India recorded a current acount surplus of USD 5.7 billion or 0.6 per cent of GDP in the March quarter. For FY24, the current account deficit narrowed to USD 23.2 billion or 0.7 per cent of GDP against USD 67 billion or 2 per cent of GDP in

A current account deficit occurs when the value of goods and services imported and other payments exceeds the value of the export of goods and services and other receipts by a country in a particular period.

India is seeking review of certain provisions of the free trade agreement with the UAE, which

came into force on May 1, 2022. The review assumes significance as experts have raised serious concerns over the spurt in imports of precious metals from the UAE under the trade agreement.

Seeking an urgent review of the pact, think tank Global Trade Research Initiative (GTRI) has stated that the India-UAE CEPA allows unlimited imports of gold, silver, platinum, and diamonds from the UAE into India with zero tariffs in the coming years.



Instagram rolling out teen accounts with parental controls

San Francisco, Sept 17: Meta Platforms is rolling out enhanced privacy and parental controls for Instagram accounts of users under 18 in a significant overhaul aimed at addressing growing concerns around the negative

effects of social media. Meta will port all designated Instagram accounts automatically to "Teen Accounts," which will be private accounts by default, the company said Tuesday.


Users of such accounts can only be messaged and tagged by accounts they follow or are already connected to, while sensitive content settings will be

dialed to the most restrictive

Users under 16 can change the default settings only with a parent's permission. Parents will also get a suite of settings to monitor who their children are engaging with and limit their use of the app.

Several studies have linked social media use to higher levels of depression, anxiety and learning disabilities, particularly in young users.

Meta, ByteDance's TikTok and Google's YouTube already face hundreds of lawsuits filed on behalf of children and school districts about the addictive nature of social media.



Last year, 33 US states including California and New York sued the company for misleading the public about the dangers of its platforms.

Top platforms, including Facebook, Instagram and TikTok, allow users who are 13 years of age and above to sign up.

Meta's move comes three years after it abandoned development on a version of the Instagram app meant for teenagers, after lawmakers and advocacy groups urged the company to drop it, citing safety concerns.

In July, the US Senate advanced two online safety bills -The Kids Online Safety Act and The Children and Teens' Online

Privacy Protection Act - that would force social media companies to take responsibility for how their platforms affect children and teens.

As part of the update, the under-18 Instagram users will be notified to close the app after 60 minutes each day. The accounts will also come with a default sleep mode that will silence notifications overnight. -

Meta said it will place the identified users into teen accounts within 60 days in the US, the UK, Canada and Australia, and in the European Union later this year. Teens around the worldwill start to get teen accounts in January.

"Obviously, Rahul bhai, Vikram Rathour (former batting coach) and Paras Mhambrev (former bowling coach) were a different team and it is only acceptable that the new support staff will bring different perspectives," Rohit said in the preseries press conference here.

Rohit used his long association with Gambhir during the latter's playing days, and with Abhishek Nayar in the Mumbai dressing room to underline his comfortable working relation with them.

"It's a new (support) staff for sure, but I have known Gambhir and Nayar long enough. Every support staff has its operating style, and that's what we were expecting," Rohit stated.

"I have worked with different coaches over 17 years of my career, and it's vital to understand that all of them have a unique perspective (about cricket), and it's a must that you adjust with them," he added on his dynamics with the new head coach and the latter's team.

Talking about the upcoming series against Bangladesh, the Indian skipper asserted that there is no need to devise a new strategy. Bangladesh defeated Pakistan 2-0 in their first win over the latter in a Test series but Rohit did not read too much into it.

It was India's sixth victory on the trot and made them sole leaders in the event as China were held to a draw by a spirited Vietnamese team that scored another great 2-2 result.

T20 WC prize money PRESS TRUST OF INDIA

Dubai, Sept 17: In a landmark decision, the International Cricket Council (ICC) announced Tuesday equal prize money for men and women in World Cups, starting with next month's women's T20 showpiece, the purse for which has been hiked by a staggering 225 per cent to USD 7.95 million.

The winners of the women's T20 World Cup will walk away with USD 2.34 million from this fund, a 134 per cent increase on the USD one million awarded to Australian women when they clinched the title in South Africa in 2023, said the ICC in a statement.

"The Women's T20 World Cup 2024 will be the first ICC event where women will receive the same prize money as their male counterparts, marking a significant milestone in the sport's history," said the ICC in a release.

The runners-up at the showpiece event next month will get USD 1.17 million in comparison to the USD 5,00,000 South Africa received for reaching the final. The two losing semifinalists will earn U,SD 6,75, 000 (up from USD 2,10,000 in 2023).


